OMB has no objection to the Department of Parks and Conservation Resources submitting a grant application to the Florida Department of Environmental Protection for the Florida Community Trust in a joint application with the City of Dunedin for acquisition of the Gladys Douglas Hackworth Property to develop a portion of the property into a recreational park.

This is a multi-year capital reimbursement grant project that will likely impact FY 22 – FY23. The requested funding is \$2.4M with a \$3.6M expected match (half of which will be provided by the City of Dunedin). The total project is estimated to cost \$6M.

The acquisition is for approximately 44 acres of land containing a residential structure, recreational building, tennis court, and various agricultural structures and sheds. Approximately 10 acres of the land include the structures, and the remaining 34 acres are undeveloped land that have species of concern. The acquisition will develop a portion of the property into a recreational park and the remaining acreage will be restored to natural habitat and protected.
