A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA; VACATING THE SOUTH 260 FEET OF 18<sup>TH</sup> STREET LYING NORTH OF AND ADJACENT TO THE NORTH RIGHT-OF-WAY OF GEORGIA AVENUE AND EAST OF BLOCK 79 AND WEST OF BLOCK 78, MAP OF SUTHERLAND, PLAT BOOK H1, PAGE 1, PUBLIC RECORDS OF PINELLAS COUNTY, FLORIDA, LYING IN SECTION 1-28-15, PINELLAS COUNTY, FLORIDA; RETAINING A PUBLIC UTILITY EASEMENT OVER A PORTION OF THE VACATED AREA; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Robert D. Saner, Jennifer L. Saner, Ben Warren Gillen, Molly Glaser, 2013-1 IH Borrower LP, and Jeffrey L. Gray, ("the Petitioners") have petitioned this Board of County Commissioners ("Board") to vacate the following described property:

WHEREAS, the Petitioners have shown that the vacation of such portions of the plat will not affect the ownership or right of convenient access of persons owning other parts of the subdivision; and

WHEREAS, the Petitioners' affidavits have been received by the Board; and

**WHEREAS,** the Board finds that the platted right-of-way which is the subject of this Resolution no longer serves a public purpose and is a proper subject for vacation pursuant to §336.09, Florida Statutes.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Pinellas County, Florida that:

1. The above-described property and plat shall be vacated, insofar as this Board of County Commissioners has the authority to do so pursuant to Section 336.09, Florida Statutes, subject to the retention of a twelve-foot-wide public utility easement lying six (6) feet on each side of the centerline of the existing water main depicted in Exhibit "A". The public utility easement shall run with the land and shall be binding on heirs, successors and assigns.

2. To the extent that the vacated area overlaps with any other public easement or right-of-way created by deed, plat, petition, maintenance, or otherwise, the subject vacation shall have no effect thereon.

3. The Clerk shall record this Resolution in the Public Records of Pinellas County, Florida.
