In accordance with the requirements of S. 218.36 (2), F.S., the Clerk has calculated the excess fees due to the Board totaling \$2,376,073.52. A copy of the check remittance is attached.

While the Clerk's Office has remitted excess fees on an annual basis for more than 10 fiscal years, this remittance is significantly higher than previous years. During FY21, the Clerk experienced a significant increase in recording revenues and subsequently planned to utilize the funds for some long awaited, high priority projects, some of which will span over to FY22.

Consequently, due to project timing, I am requesting a portion of the excess fees be returned to the Clerk's Office through a \$1,354,605 amendment to the Clerk's FY22 Board funded budget. In collaboration with the County's Office of Management and Budget, the amendment will be presented for your approval in November:

The budget amendment will fund the following projects:

- 1. Budget management software, Clerk instance \$204,605
- 2. Functional resources for Oracle implementation/enhancements \$750,000
- 3. Real Estate Management (REM) project, renovations at the Swisher Building for additional office and storage space for Clerk Technology \$400,000
