SECOND AMENDMENT

This Amendment made and entered into this 13th day of <u>December</u> ____, 2022, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and CDW Government LLC hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on November 9 2021, pursuant to Pinellas County Contract No. 21-0201-PB (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Information Technology Solutions & Services for County; and

WHEREAS, Section 7. Term of Agreement and Spending Cap, Subsection b. Term Extension of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a two (2) year extension, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- 1. Term of the agreement is extended from February 28, 2023, to February 28, 2025.
- 2. Section 7. Term of Agreement and Spending Cap, Subsection c. Spending Cap is revised to reflect an increase in the amount of nine hundred and fifty thousand dollars and zero cents (\$950,000.00) for a revised total not-to-exceed sum of one million nine hundred thousand dollars and zero cents (\$1,900,000.00).
- 3. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.
