Summary

- The proposed First Amendment will increase the not-to-exceed threshold by \$465,000.00 for a revised total of \$1,123,320.00. The term length will also be increased by 12-months with a new end date of June 30, 2025.
- Expenses will be made from PCU's Operating Budget and funding will be derived from the Water Revenue and Operating Fund.
- PCU has budgeted \$416,000.00 in FY24, which is sufficient to meet the needs of this fiscal year.
- The 12-month term extension will also allow for expenses in FY25. This will be considered during FY25 budget development.

Background

Pinellas County Utilities (PCU) is seeking the approval of First Amendment to the Contract with Condy Holdings LLC, doing business as Craus LLC (Condy), for the proprietary corrosion control chemical blend used in the PCU water system. The original contract was approved with a term of 24 months (July 1, 2022, through June 30, 2024) and a not-to-exceed threshold of \$658,320.00, with an annual average expenditure of \$329,160.00.

If approved, First Amendment will increase the not-to-exceed threshold by \$465,000.00, or 70.6%, to \$1,123,320.00 and execute the first of three 12-month contract term extensions. Approval will adjust the term from July 1, 2022, through June 30, 2025, and increase the average annual expenditure by \$45,280.00, or 13.8% to \$374,440.00.

Utilities has budgeted for this contract in the FY24 Adopted Budget and does not expect approval of this amendment to cause a need to adjust spending or the budget. If there are unforeseen expenses that are higher than the budget in FY24, it is likely Utilities could absorb it without any additional action needed.

This increase in the not-to-exceed threshold and the 12-month extension will primarily impact FY25's budget and Utilities will include this during FY25 budget development.
