Approval of the renewal Certificates of Public Convenience and Necessity (COPCN) for the attached list of Advanced Life Support (ALS) providers.

COPCNs are issued by Boards of County Commissioners (BCC) in all Counties in Florida. The
certificate allows Emergency Medical Services (EMS) provider agencies to be licensed by the
Florida Department of Health.

- The certificate process ensures there are coordinated and regulated EMS Systems at a County level.
