I own a pet grooming business in Oldsmar. I am not in favor of pet grooming salons being allowed to re-open and to be classified as an essential service. Yes, we can have pets dropped off and picked up without contact with the owner. Yes, we can follow CDC guidelines for disinfection and distance. Yes, dogs do need regular grooming. And yes, closure causes temporary financial hardships (for which the government has initiated aid programs). Many of our customers realized that we may have to close and brought their dogs in for grooming in March. I assure you, regularly groomed dogs will not suffer because groomers close shop for a month. The dogs that suffer from lack of grooming haven't been groomed in months and are not likely to be getting groomed anytime soon because the owners are unaware of their dog's condition or don't care. Hello, and hope you are well.

I would like to start by saying that I am a dog groomer out of Palm Harbor, and as much as I love my job and could really benefit from a paycheck I must say that the realities of dog grooming make it impossible to keep the CDC-recommended six feet of distance away from other people. Many times throughout the day it takes two employees standing face to face to hoist a large dog onto a grooming table or into the tub that sits 3-4 feet off the ground and to give support to make sure it didn't squirm while getting its hair cut or nails clipped. In order to even assess the dogs skin and coat prior to grooming we have to gather "grooming notes" and to do so we come into contact with the dog's owners, just like when you get your hair cut, you tell your stylist how and what you want. On a whole other note we aren't even so sure that the virus can't live on the pets coat, all we would have to do is essentially touch a dog from an infected household and possibly be putting ourselves and our families at risk. Any veterinarian is capable and willing to clip nails, or express anal glands. They are also able to shave coats if necessary due to matting, or hotspots, there is no reason dog groomers should be considered any different from hair stylists. I work in a small shop, we are not offered masks or gloves, and our salon isn't even big enough for the 4 of us to be at a safe distance from one another. Please help keep our families safe too.
