WHEREAS, the Petitioner, through its authorized agents has executed a utility easement over the portions of the lands further described in Exhibit "A"

WHEREAS, the Board finds that the portion of the petitioned right of way that are subject of this Resolution no longer serve a public purpose and are a proper subject for vacation pursuant to §336.09, Florida Statutes.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pinellas County, Florida that:

The above-described property depicted in Exhibit "A" shall be vacated, insofar as this
Board of County Commissioners has the authority to do so pursuant to Section 336.09,
Florida Statutes and subject to the retention of a public utility easement over the same
vacated area.


