### **REASON FOR CHANGE:**

Final inspections have been conducted for all Work performed under the contract terms by the representative of the Public Works Construction Management Division. Substantial completion for this Project was achieved on February 3, 2020. The public has had beneficial use of all Project areas since February 3, 2020. The Project was completed with Final Acceptance granted on September 14, 2020. All Work has been completed in accordance with the Plans and Specifications. The Agreement term has been extended by 213 consecutive Calendar Days. No liquidated damages shall be assessed.

Final pay quantities have been computed for the Project and are adjusted to reflect the difference between the preliminary estimated quantities and the final quantities, resulting in a net total decrease of (\$43,595,51).
