HUMAN SERVICES FUNDING AGREEMENT  
FIRST AMENDMENT

THIS FIRST AMENDMENT, effective upon the date executed below, by and between **PINELLAS COUNTY**, a political subdivision of the State of Florida, hereinafter called the "**COUNTY**," and **ECKERD YOUTH ALTERNATIVES, INC. (d/b/a ECKERD CONNECTS)**, a non-profit Florida corporation, whose address is 100 Starcrest Drive, Clearwater, Florida 33765, hereinafter called the "**AGENCY**." The Parties hereby amend the HUMAN SERVICES AGREEMENT with ECKERD CONNECTS between the **COUNTY** and **AGENCY** dated \_\_\_\_\_, as follows:

WITNESSETH:

WHEREAS, the **COUNTY** desires to provide for local services that support child welfare within Pinellas County; and

WHEREAS, the **COUNTY** is committed to both enhancing the delivery of human services and increasing citizen access to those services; and

WHEREAS, the **COUNTY**, in partnership with local providers and stakeholders, applied for and received a Federal Grant Award from the U.S. Department of Justice, hereinafter referred to as the grantor, under the 2019 Opioid Affected Youth Initiative grant program, hereinafter referred to as "the grant"; and

WHEREAS, the **COUNTY** received approval from the grantor to enter into an agreement with the **AGENCY** as a sole source provider; and

WHEREAS, the **COUNTY** recognizes that the **AGENCY** is providing an essential service within the community; and

WHEREAS, pursuant to Federal Super Circular Section 2 C.F.R. § 200.74, the **COUNTY** is a pass-through entity for purposes of this Federal award; and

WHEREAS, the **COUNTY** recognizes that the **AGENCY** responds to critical needs within the community as the lead child welfare community-based agency in the County;

**NOW, THEREFORE**, the parties hereto do mutually agree as follows:

1. **Section 1. Specific Grant Information**, is hereby amended to add the following:  
2 (vii) Total Amount of Federal Funds Obligated to the Agency by the Pass-Through Entity Including the Current Obligation: \$691,518.00.
2. **Section 2. SCOPE OF SERVICES**, is hereby amended to add the following:  
**AGENCY** agrees to secure needed services for children as identified through this grant project, Memorandum of Understanding and Work Plan by utilizing its Purchase-of-Service System. These services will be in addition to the level of service currently provided to children in dependency cases. New services will not be required to be court ordered for these referrals to be made and will not be limited to services covered by Medicaid.
3. **Section 4. COMPENSATION**, is hereby amended to add the following: **COUNTY** shall increase maximum compensation under the Agreement by \$507,103.00. The **COUNTY** agrees to pay the **AGENCY** a total three-year amount not to exceed \$691,518.00, for the services described in Section 2 of the Agreement and this Amendment.
4. Except as herein provided, all other terms and conditions of the Agreement remain in full force and effect.
5. This First Amendment shall take effect immediately upon execution by the Parties.
