Agreement made between Sports Surfaces LLC. hereinafter called the Contractor and Feather Sound hereinafter called the Customer for the construction of (2) pickleball courts with respect to the following terms and specifications:

ASPHALT

Court Size: 64' x 64' (2) Pickleball Courts each court 34' x 60'

The Customer will provide HOA approval and septic tank/well location if applicable.

The Customer will provide stable access to construction site. A minimum of 20' wide access required for equipment access. If equipment cannot access construction site an additional charge for manual labor installation of rock base and asphalt will apply.

The Contractor will excavate grass. Tree/stump removal not included.

The Customer will remove existing sprinkler lines and cap off.

The Contractor will install 6" compacted lime rock or shell rock sub base

The Contractor will install 1.5" of SIII asphalt compacted to 1".

Please note: New asphalt has to cure for a min of 28 days prior to surface installation.

SURFACING OF PICKLEBALL COURT(S)

The Contractor will pressure clean and power blow court(s) as necessary to remove loose dirt, mildew and oil.

The Contractor will patch depressions greater than 1/16" after 1 hour drying time in sunlight, grind down any ridges as necessary.

(2) Coat of Acrylic Resurfacer over entire court area to fill voids and provide smooth surface.

(2) Coats of Color Concentrate (two-tone). To provide in depth color over court surface. Color Choice _____

The Contractor will locate, mark, and paint playing lines in accordance with USPA regulations using white textured heavy bodied acrylic latex paint.

EQUIPMENT

The Contractor will install (2) pairs of net post footers with sleeves to make posts removable for future replacement.

The Contractor will install (2) pairs of Douglas pickleball net posts- Deluxe SW32 2 7/8", (2) pickleball nets and (2) center straps.

The Owner shall treat the soil with a sterilant (Pramatol, Round-Up, or equal) that will effectively inhibit future growth of flora. In the event Owner cannot remove such vegetation, Owner will install a root barrier completely around the circumference of the playing surface. GUARANTEE

The Contractor guarantees all work against defects in workmanship or materials for a **period of (2) years** from date of completion. This guarantee excludes Normal wear and tear, physical abuse or neglect and any other conditions beyond the contractor's control, such as sub-base settling, structural cracks, asphalt shrinkage cracks, hydrostatic pressure or water vapor pressure bubbles, intrusion of weeds or grass, etc. Sub-base settling may cause new puddles to form on the surface which would not be covered under the warranty. Proper tennis shoes must be worn on court. Some sneakers, street shoes, dark soled shoes, skateboards, roller blades, etc. will scuff and damage surface. Guarantee shall become void upon owner's failure to adhere and comply with the payment schedule.
