Early last year I wrote the below e-mail to our Commissioners.....I believe it is worthwhile reviewing again what was said.

The **Citizens of our Community are Blessed to be living where we currently do**. Our neighborhood, which surrounds the **Tides Golf Course Recreational Open space is an UNINCORPORATED AREA IN PINELLAS COUNTY**, and not part of the City of Seminole.... but the City and our area tells an important story of the expansive changes our Community has seen over the ages!

CITY OF SEMINOLE

A City created in the orange groves of western Pinellas county became City of Seminole officially on November 15, 1970. A land where once 4,000 individuals called creek Indians made their home.

This was the land where they lived, hunted deer, rabbit ,wild turkeys...fished and grew corn.

Mastodons , giant sloths, saber-toothed cats and armadillos the size of Volkswagen beetles once called this home; citrus farmers grew and prospered here, cattlemen raised their stock here. Today Seminole is a bustling city of more than 18,886 residents.

Trailer parks and mobile home developments helped ease the housing demand in the early 1960s. Holiday camp ground was a 101 acre park on the other side of park blvd from lake Seminole that grew and prospered in Seminole City. In 2003, that same 101 acre park was sold to condo developers for \$14 Million or \$138,614 per acre.

Can you see the history of our area! The Tides GC RECREATIONAL OPEN SPACE is filled with that history. Just think what lurks below the historic soil of the Tides! Giant mastodon pieces plus all the other great creatures that roomed our area, plus the Indians and their history. Just go to our History Museum in Seminole Park.....you will be amazed at the historic findings in our Community!

A lady by the name of Gwen wrote on our SAVE THE TIDES web site, "A GREAT PLACE TO LIVE NEEDS PARKS AND GREEN SPACES!"

Just think of what **New York** would look like **without it's CENTRAL PARK!** New York's founders had a vision of what New York would be and realized **GREEN SPACE must be preserved for FUTURE GENERATIONS! THANK GOD THEY WERE VISIONARIES!**

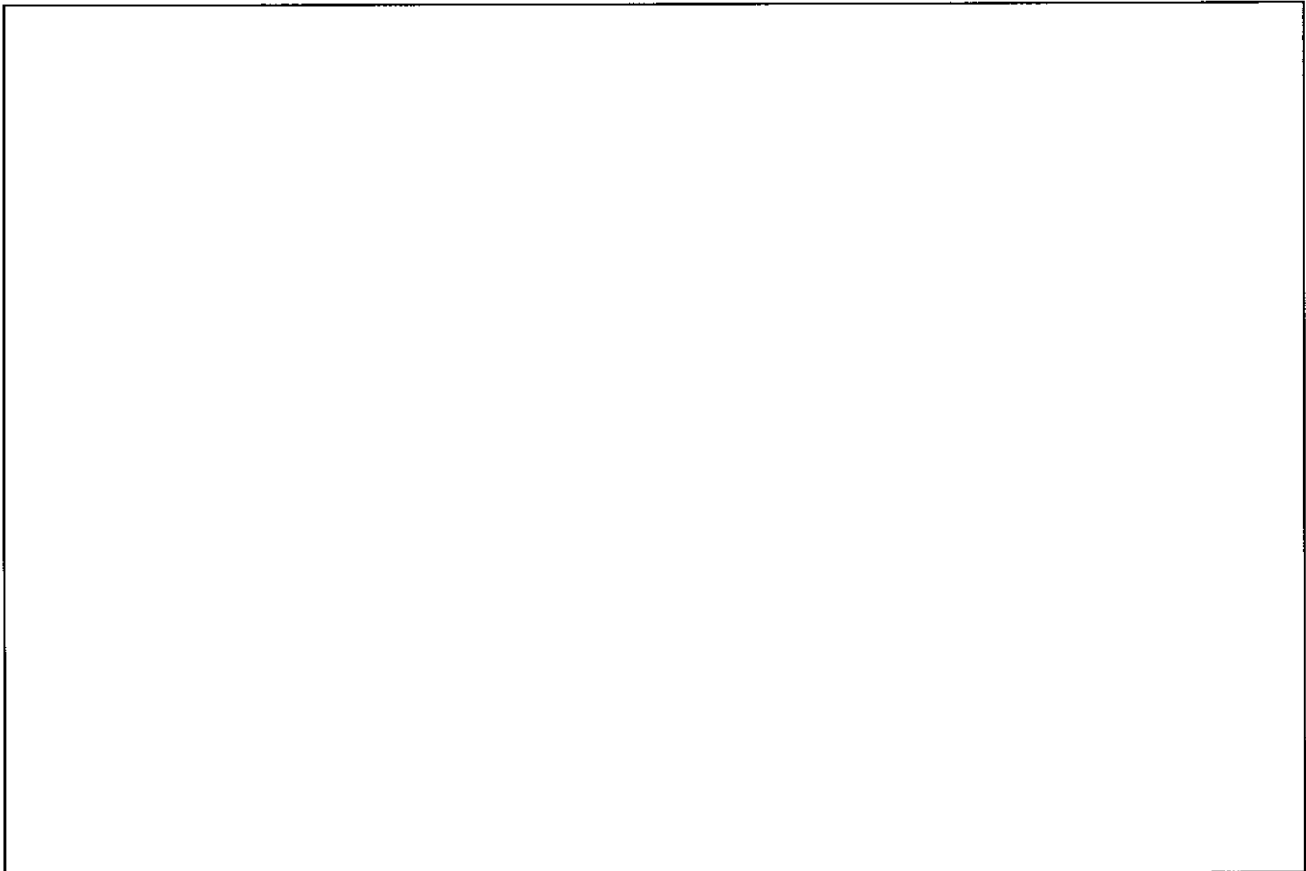

LEMON CREEK PRESERVE started with an abandoned golf course(It Ran from 1971 to 2006)....much like the Tides did and looks like today. Through the efforts of the Community, NOAA and the SOUTHWEST FLORIDA WATER MANAGEMENT DISTRICT, they took a piece of property and turned it into land that is used for:

- 1. Storm Water Protection**
- 2. Improvements for HABITAT Survival**
- 3. A Cleansing Platform to help keep our Intra Coastal Water Ways and Bay free of nutrients.**
- 4. Helped to protect the restoration of our Aquafer Drinking water as well.**

This project was hailed by our Governor at that time because it met all of the standards he had been pushing for improving our water quality both fresh and salt water throughout the State of Florida. Much like our Current Governor is doing!

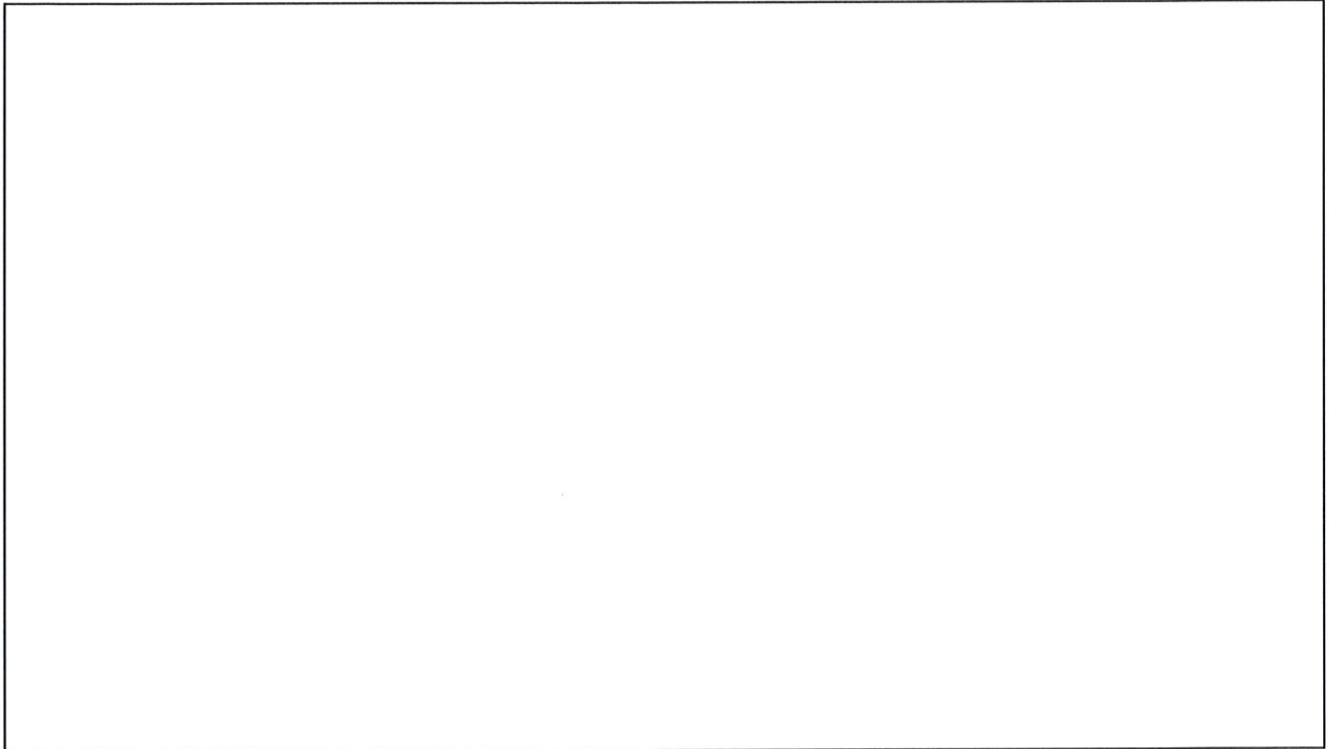
Just imagine, maybe we can never again have the beautiful golf course that Mr. Hills destroyed on us that you see below:

That is what LEMON CREEK WILDFLOWER PRESERVE did for Charlotte County below:



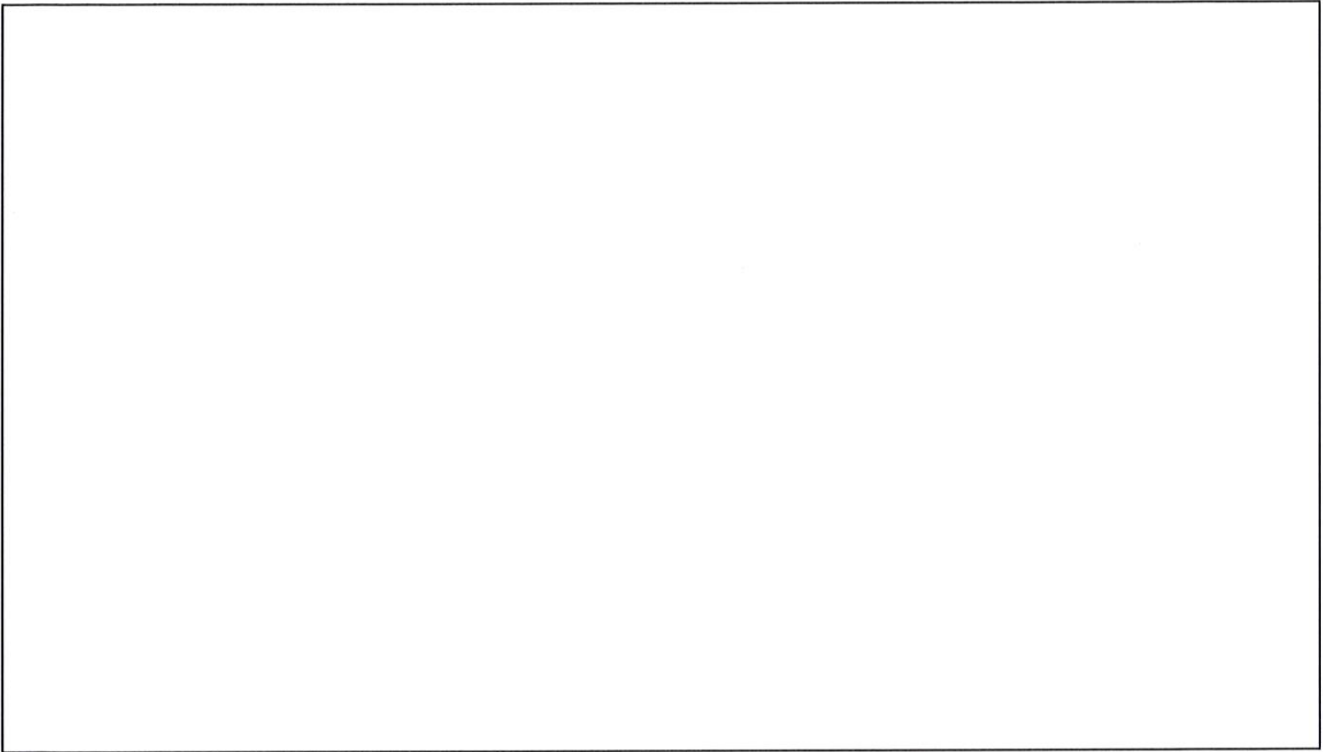
LEMON CREEK WILDFLOWER PRESERVE is where people can enjoy the outdoors that God created for us. Plus it benefits their COMMUNITY for recreation, wild life preservation, storm water protection and just a beautiful 80 acres of land you can admire!

Go to Lemon Creek Preserve to view their video. It will just knock your socks off as to what you can do to make land work for you.

Our COMPREHENSIVE PLAN states: we must consider both visual and environmental impact on our County as a whole should private golf courses gradually be replaced by development! The IMPACT WOULD BE DRAMATIC! THIS IS A GREAT WAY TO MAKE THE TIDES AN EVEN BETTER

HABITAT for all of the wildlife that depends on the TIDES for their survival!

Another Preserve called the ROBINSON PRESERVE that you see below:



The Robinson Preserve is 150 acres of land in Manatee County. That is the size of our Tides Golf Course property. This land does everything that the Lemon Preserve does plus it is used to improve the stocking of redfish allowing 10-12" long redfish to be released into the preserve which flushes into the bay area having a place for the redfish to flourish!

WE all know that Pinellas County is the second smallest County in Florida, yet the Most Densely Populated County in all of Florida! Pinellas has a density of 3,499 people per acre. Miami-Dade has 1,430 people per acre. WE ARE 2.45 TIMES MORE DENSELY POPULATED THAN THE MIAMI AREA!

WE ARE A BUILT OUT COUNTY....WE MUST NOT LOSE RECREATIONAL OPEN SPACE FOR MORE DEVELOPMENT!

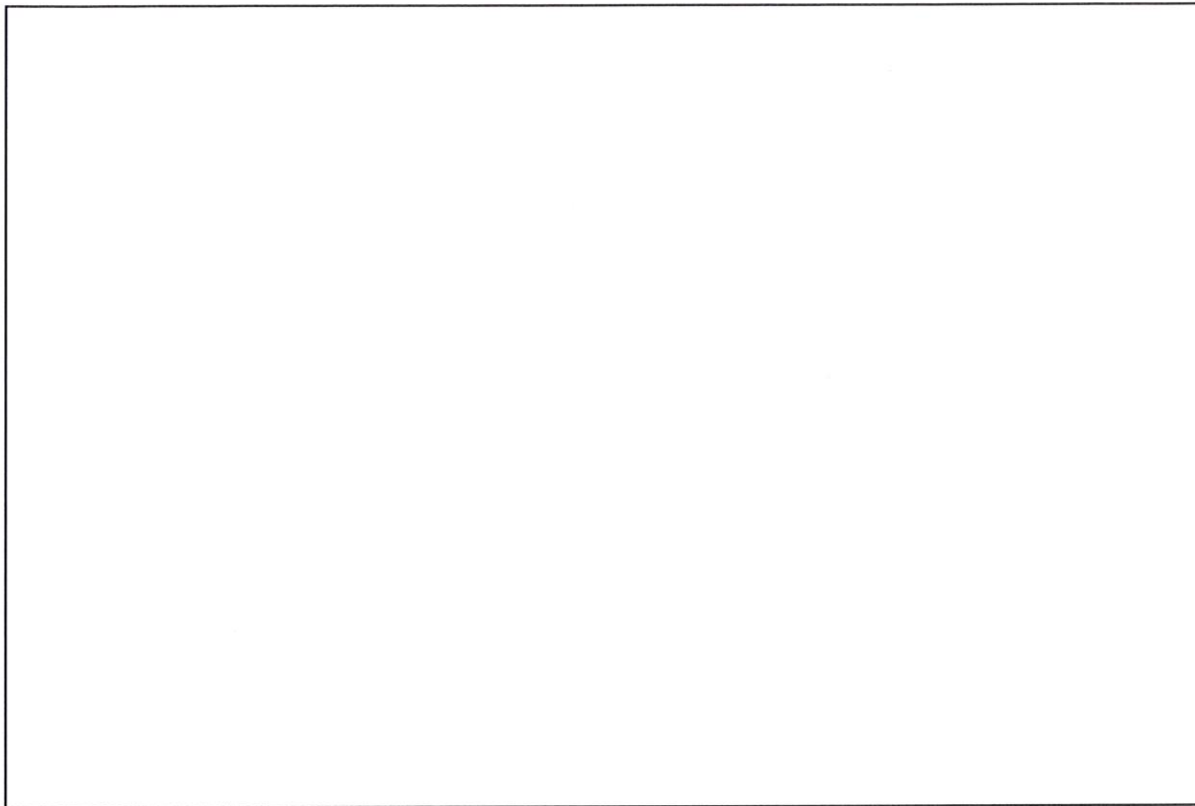
There are plenty of projects going on in our County where town homes, Condos, Individual homes and apartments are taking place in massive numbers. 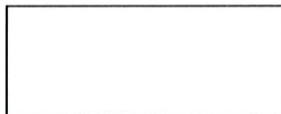

Not long ago our **PRECIOUS GREEN SPACE CALLED THE TIDES GOLF COURSE** looked like this:



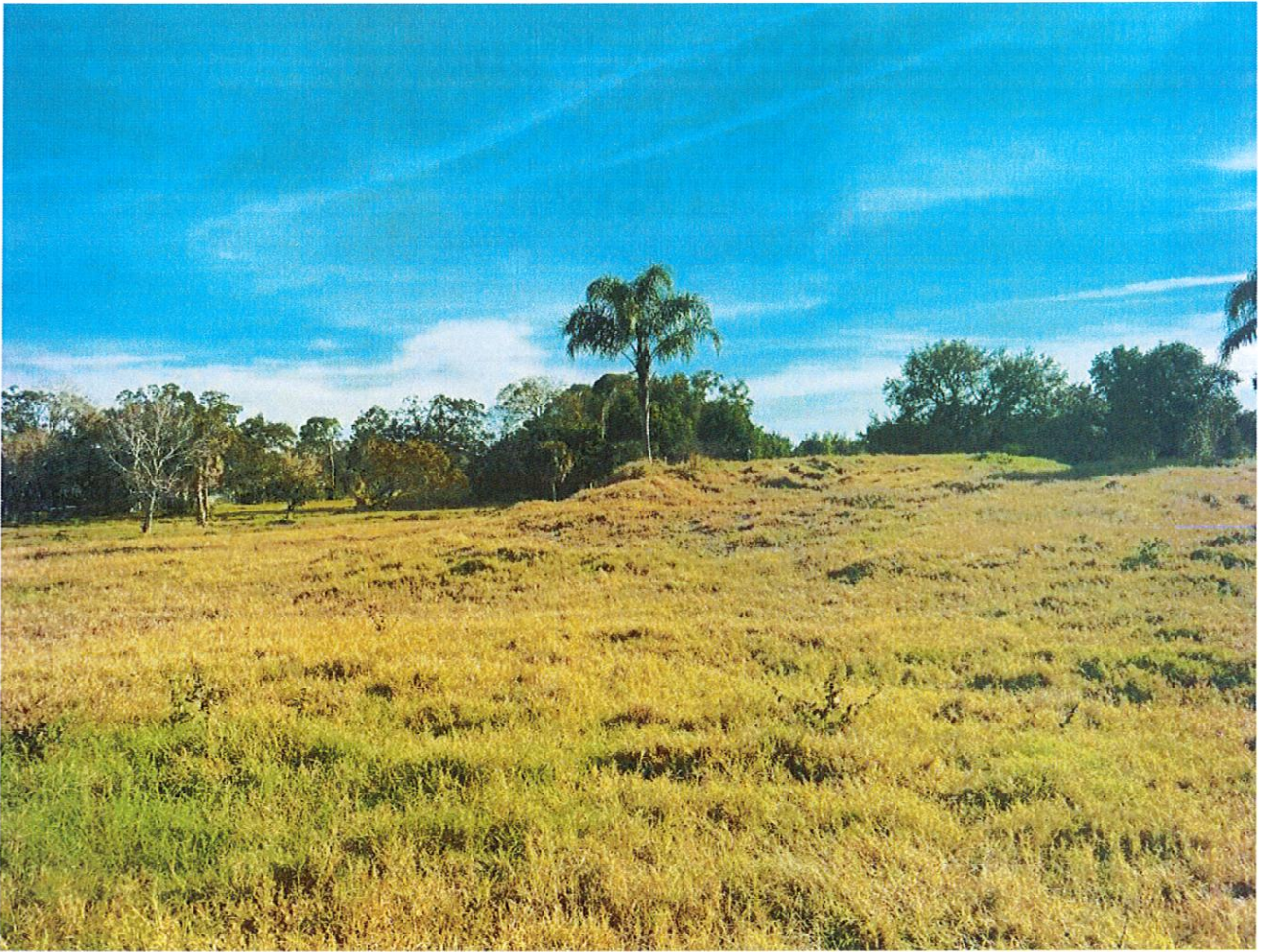

It is so sad that our Community has had to endure a battle to SAVE OUR PRECIOUS RECREATIONAL OPEN SPACE called the TIDES GOLF COURSE going on **NINE YEARS** now! During that time, two developers have tried to win over our County to develop the Tides. TWICE NOW...THESE TWO DEVELOPERS WERE TOLD THE COUNTY STAFF OF ENGINEERS WAS RECOMMENDING DENIAL GOING FORWARD OF ANY DEVELOPMENT OF THE TIDES!

NOW OFCOURSE, THE DENIAL OF THE CURRENT OWNER TO DEVELOP THE TIDES HAS GONE BACK TO OUR COUNTY ENGINEERS BECAUSE THE DEVELOPER CLAIMS HE KNOWS MORE THAN THE COUNTY ABOUT OUR COMPREHENSIVE PLAN! **WE MUST PROVE HOW WRONG HE IS!**

We now realize MORE THAN EVER that **Mr. Hills was the WOLF** that entered OUR COMMUNITY **in SHEEPS CLOTHING**NOT "TO SAVE THE TIDES" as Mr. Carpenter, his partner once said to me...but to DESTROY OUR PRECIOUS RECREATIONAL OPEN SPACE!

Just look at what our County presently has BELOW, get rid of it with development and you will never, ever be able to replicate it again! We just cannot let this PEARL in OUR PINELLAS COUNTY OYSTER be plucked and destroyed!

Hillsboro County where Mr. Hills has established his business, **actually started a program called ELAPP (Environmental Lands Acquisition and Protection Program) back in 1987.**

ELAPP was born in a 1987 referendum, when county voters overwhelmingly chose to dedicate funding to purchase environmentally sensitive lands. The program is non-regulatory and only acquires parcels from willing sellers. Anyone can nominate a property for ELAPP consideration, which triggers a review by county staff and the public ELAPP committee.

By 2017, the 30th Year Anniversary of its program, ELAPP had purchased over 61,000 Acres of sensitive Land!

- - The Board of County Commissioners approved an Environmentally-Sensitive Lands Ordinance, which provided \$21 million over a four-year period to acquire environmentally-sensitive lands
 - That Land Ordinance began a glorious ride to save thousands of acres of land that otherwise might have fallen into the hands of Developers like Mr. Hills!

Lands such as you see below, **Hillsboro County saved through ELAPP**, they are now **sensitive and beautiful pieces of property** that are being enjoyed by old and new generations for many eternal years to come!

It is such a precious piece of land that our County, Our Community must not lose it!

We must somehow find a way to SAVE THE TIDES LIKE HILLSBORO COUNTY HAS SAVED 61,000 ACRES of their County for PRESENT AND FUTURE GENERATIONS!

Mr. Tew, Mr. Hills Lawyer and their Group will try anything to get this development through. They even had a ZOOM Meeting with Pinellas County Staff to see if there was some way of getting around the **County Staff of Engineers' Recommended Denial** going forward of their Development Plan! Mr. Tew's little maneuver did not work. **THE RECOMMENDED STAFF DENIAL GOING FORWARD TO THE LPA BOARD COULD NOT BE CHANGED!**
