This memo serves to inform you that the Division of Inspector General completed an unannounced audit of the Contractor Licensing Department's Change Fund on May 16, 2025.

The objective of our audit was to reconcile the Change Fund and ascertain that the appropriate internal controls, safeguards, and policies and procedures were being followed, safeguarding the County funds under your departmental control.

Our audit was conducted in accordance with the *Global Internal Audit Standards* of The Institute of Internal Auditors and the *Principles and Standards for Offices of Inspector General* of the Association of Inspectors General. Accordingly, it included such tests of records and other auditing procedures as we considered necessary in the circumstances.

Based on our independent and objective assessment, the department's governance, risk management, and internal control environment are effective for the scope of this audit. Governance, risk management, and/or internal controls are operating effectively and consistently applied to support the achievement of objectives in the area audited. We identified areas of strength where controls are strong and aligned with the department's goals, and the Change Fund reconciled to the authorized amount.
