Dear Commissioners,

I was dismayed to find out that the contract between Pinellas County Government and the University of Florida/IFAS is in jeopardy. As the Faculty Director of the Eckerd College Community Farm, Environmental studies professor, and private resident of Pinellas County, I have benefited tremendously from the services and expertise provided by UF/IFAS extension over the past 12 years that I have lived and worked here. Our programs at the EC Farm are explicitly liberal arts in nature, meaning that we do not provide agronomic or technical education and frequently rely on the agronomic and ecological expertise of our county UF/IFAS colleagues. Pinellas UF/IFAS Extension has been a valued partner in supplementing our coursework in Environmental Studies at Eckerd, assisting myself and numerous colleagues with our classes such as Gardening for Sustainability, Food & Sustainability, Green Design, and more. A loss of local extension programming would diminish the educational opportunities we are able to offer our students. Additionally on our campus farm and in my home garden, I have often had cause to consult our local UF/IFAS extension regarding soil and pest issues and found their input invaluable. As you likely know, Florida has many microclimates and so hyper-local knowledge is paramount for sustainable food production. So much would be lost if Pinellas County Government did not renew its MOU with UF/IFAS. On behalf of my students, colleagues, and friends and neighbors, I strongly encourage you to continue to support UF/IFAS in Pinellas County. Thank you for taking the time to consider my perspective.

I am writing to express support for the programming offered by the University of Florida IFAS Pinellas County Extension Program.

The Tampa Bay Estuary Program (TBEP) is one of 28 federally-recognized National Estuary Programs, an independent special district of the state of Florida, and an intergovernmental partnership whose mission is to build partnerships to restore and protect Tampa Bay. Pinellas County has been a key partner and regional leader since the Program's inception in 1991. As such, the County has pledged, through a binding [Interlocal Agreement](#), to help achieve the science-based goals and priorities of [Charting the Course: The Comprehensive Conservation and Management Plan](#) for Tampa Bay (CCMP).

The CCMP identifies numerous activities to ensure that Tampa Bay remains a vibrant part of the region's environmental and economic landscape, as well as those parties responsible for its proper and effective implementation. According to the CCMP, the UF IFAS Extension supports several priority actions, including reducing nitrogen runoff from urban landscapes ([SW-1](#)), expanding adoption of best management practices for commercial and urban agriculture ([SW-8](#)), developing education to reduce fertilizer use where reclaimed water is applied through the Florida Friendly™ Landscaping Program ([WW-1](#)), promoting education about plastic pollution prevention through the Florida Microplastic Awareness Project and the Florida Water Stewardship Program ([COC-4](#)), continuing public education campaigns to reduce pet waste in the bay watershed ([PH-4](#)), offering training and support to volunteers in specific creekside neighborhoods ([BH-9](#)), reducing user conflicts and managing recreational uses of the bay ([PA-1](#)), and enhancing community understanding of the impacts of sea level rise on coastal habitats ([CC-1](#)).

In short, Pinellas County Extension has been an impactful program, providing benefits to the residents of our region and addressing core actions outlined in the CCMP. We look forward to continuing work with Pinellas County to ensure that progress is made to improve water quality, habitats, and quality of life throughout the Tampa Bay watershed. The University of Florida Institute of Food of Agricultural Sciences (UF/IFAS) is a long-standing partner of the Southwest Florida Water Management District (District). We understand the Commission is holding a workshop November 13 to discuss the Pinellas County Extension's contract renewal and we are writing to express our support for the Extension.

On the statewide level, UF/IFAS provides critical research, guidance and programs on residential lawn and landscape efficiencies as well as agricultural water use and water quality. At the local level, the Extension offices provide hands-on water resources education, services, workshops and materials to residents and key stakeholders. Many of these services are provided by volunteers, thus reducing costs.

Moreover, with the influx of new residents over the past five years and the potential for water shortage orders due to dry conditions, providing boots on the ground education on water conservation and water quality is more critical than ever. Our research shows that residents in our region are increasingly uninformed on basic water conservation and fertilization practices. Programs such as Florida-Friendly Landscaping focus on helping residents protect Florida's natural resources by conserving water, reducing pollution and supporting wildlife through sustainable landscaping practices. In addition, the Pinellas County IFAS irrigation evaluations have been valuable tools to help homeowners save money on their water bills while enabling Pinellas County to reduce wasteful water use.

The District strongly supports the UF/IFAS Extension Pinellas County office as an important local resource to the public for water resources education and urges the Pinellas County Commission to continue its funding of the program.

Florida Master Gardener Volunteers assist UF/IFAS Extension Agents by providing research based horticulture education to Florida residents. The Vision of UF is to be the most trusted resource for horticulture education in Florida. The MGVS Program extends the vision of UF/IFAS by protecting and sustaining natural resources. Dear County Commissioners:

I am writing this letter as a concerned resident of Pinellas County and a Master Gardener Volunteer of the University of Florida Institute of Food and Agricultural Services (UF-IFAS). I have been a Master Gardener Volunteer with the Pinellas County Extension Office since December 2020 and have served over 887 volunteer hours during my five years in this program.

I am deeply concerned about the proposed cuts that the Commissioners are contemplating to “defund” the Pinellas County Master Gardener program. Before any such decision is made, the Commission should be made fully aware of the impact that this program has on the health and well-being of not only the residents of Pinellas County, but also the impact on the economy and on environmental preservation in one of the most densely populated of the 67 counties in Florida.

As a Master Gardener Volunteer coordinator for the monthly North Pinellas County Plant Clinic, I can personally attest to the fact that this program provides unparalleled value in terms of free education and professional advice to patrons of all ages who frequent the information desk during the Folly Faires at Folly Farm Nature Preserve in Safety Harbor. We typically employ 3 to 4 Master Gardeners at the help desk who answer questions ranging from landscaping problems to identification of plant diseases offering helpful advice and science-based solutions. The Master Gardeners are the trusted “bridge” between science and everyday life in the community. Children of all ages come to Folly Farm with their parents and often stop by the Plant Clinic, which also exhibits a display table for the “Plant of the Month” and the Pollinator Pathway highlighting the importance of attracting pollinators in the home landscape. Master Gardener volunteers are also requested by Pinellas County Schools and the Sheriff’s Youth Ranch to teach children the basics of gardening; for example, how does our food get from farm to table, etc.

The power of the Master Gardener Volunteer program cannot be underestimated. It is the largest volunteer program in the nation with a monetary value estimated at \$11 million dollars. With the growing food insecurity in this country, the Master Gardener Volunteer program is even more relevant in today’s economy to help promote community gardens, donate and grow food for food banks, especially in underprivileged or unincorporated areas. Pinellas County also has a high volume of tourists that visit our parks and beaches year-round. The Master Gardener volunteers add value to the 17 County parks, four



environmental preserves, the Florida Botanical Gardens and many municipal and neighborhood parks in terms of beautification, preservation, and removal of invasive plants to help parklands thrive and attract birds and other wildlife that tourists have come to enjoy. Lastly, with Pinellas County's 588 miles of coastline, Master Gardener Volunteers are often called upon for beach renourishment projects after severe weather events such as Hurricanes Helene and Milton, again providing free and valuable consultation to businesses and residents, help that would be otherwise unavailable.

In short, Pinellas County Master Gardener Volunteers come from all walks of life, retired engineers, schoolteachers, Army officers, plant nursery owners, medical professionals, tree arborists, landscape architects, etc. So much talent exists in this county-wide program, why would the County Commissioners dismiss this talented group of men and women who so willingly give of themselves and tirelessly give back to this community and have enriched the lives of so many people? Please vote with your conscience and immediately allocate funding to defray the administrative costs of the Pinellas County UF-IFAS Extension Program.
