This is a civil action in which Plaintiff alleges negligence against the County and seeks monetary damages for personal injuries allegedly arising out of a trip and fall on a foreign substance on a sidewalk on July 20, 2021, at or near 150<sup>th</sup> Ave. N. in unincorporated Clearwater, in front of Highpoint Elementary.

Plaintiff's medical bills to date exceed \$300,000.00 and given the potential liability exposure, it is recommended that the County Attorney's office be authorized to accept the Plaintiff's Proposal for Settlement in the amount of \$150,000.00, inclusive of all costs and claims for attorney's fees.

Approval of this settlement is recommended by Risk Management, County Administration, and the County Attorney's Office.
