## Summary:

This is an action arising out of allegations of discrimination based upon Mr. Bavlsik's disability and age in violation of the Age Discrimination in Employment Act (ADEA) and Americans with Disabilities Act (ADA), and includes a claim of retaliation as a result of Mr. Bavlsik's employment termination by Pinellas County Business Technology Services. Mr. Bavlsik submitted his claim to the U.S. Equal Employment Opportunity Commission, Tampa Division.

Mr. Bavlsik was an employee of Pinellas County Business Technology Services (BTS), or its predecessor, for approximately 22 years, and alleged that he was struggling with disabilities and medical issues related with those disabilities. He claims he was chastised and criticized for using his personal time off to attend doctor appointments and was forced to use FMLA, and that he received disparate treatment when compared with his younger and non-disabled colleagues.

BTS denied those claims and allegations. Prior to terminating Mr. Bavlsik, the matter was referred to Paul Valenti, Office of Human Rights, to conduct an investigation into Mr. Bavlsik's claims and allegations. Mr. Valenti found that Mr. Bavlsik's claims could not be established by a preponderance of evidence.

The EEOC investigator conducted his own fact-finding investigation. The Commission determined that the evidence obtained did establish a violation of the ADA in regards to the allegation of discrimination and retaliation due to Mr. Bavlsik's disability but was unable to conclude that there had been any violation of the ADEA.

In an attempt to eliminate the alleged unlawful practices by the informal method of conciliation, the EEOC invited Mr. Bavlsik, his counsel, a representative of BTS and their counsel to a conciliation conference. Progress was such at the conference that the EEOC granted the parties and their counsel additional time to negotiate an amicable resolution.

The EEOC, parties, their representatives and their counsel reached a conditional settlement agreement that would resolve all claims, potential claims, cross-claims and counter-claims. If approved, Pinellas County would pay to Joseph Bavlsik the sum of \$87,500.00 and Mr. Bavlsik would execute a release, releasing Pinellas County from all claims, past, present and future, known and unknown that Mr. Bavlsik might have. Each party has agreed to bear their own attorneys' fees and costs. Mr. Bavlsik, a representative of BTS and the EEOC will execute a Conciliation Agreement prepared by the EEOC once this matter is approved.
