Description & Comments

This item is for the approval and execution by the County Administrator of an Employment Sites Program (ESP) Funding Agreement for a sum of not-to-exceed \$3,544,079.00 to construct a new 35,842-square-foot headquarter office space and research and development space.

The Board of County Commissioners (BCC) approved funding for the Monin, Inc. HQ Expansion on July 22, 2025, in the amount of \$3,544,079.00. The BCC also authorized the County Administrator to execute and negotiate all terms and agreements in relation to this project (Granicus Item 25-0952A).

The project site is located at 2100 Range Road, Clearwater. The project will result in the construction of a new 35,842 square foot headquarter office space and research and development space. The County portion requested is for funding needed for demolition, removal and replacement of the vault system, and dirt required to raise the site.

This item is for the execution of the Employment Sites Program (ESP) Funding Agreement with Monin, Inc. The agreement is issued in the amount of \$3,544,079.00. for a contract period of 20 years from the effective date. The County will pay Monin, Inc. in three separate payments. The first payment will be made following the slab inspection approval in the amount of \$1,181,359.00. The second payment will be issued after roof inspection approval in the amount of \$1,181,359.00. The final payment will be provided after a certification of completion has been received in the amount of \$1,181,361.00.

The total requested County contribution for this project is \$3,544,079.00. Including this item, the total amount of Penny IV affordable housing funds committed is \$44,596,765.00 out of the \$98,000,000.00 currently estimated in all ten years of Penny IV.

Funding for this project is included in the FY25-FY30 Capital Improvement Program under the Economic Development Capital Projects (project 004149A). This project is funded by Local Infrastructure Sales Surtax (Penny for Pinellas), as part of the 8.3% countywide investment for Economic Development and Housing, half of which, or 4.15%, is set aside for Economic Capital Projects specifically.

The Economic Development Capital Projects (project 004149A) has a FY25 Budget of \$25,183,000.00. FY25 Expenditures are estimated at \$9,381,306.00.
