Mr. Scott -

I was stunned when I read about the County Commission's 5-2 vote to defund Creative Pinellas. I am writing to ask you, as a member of the Tourist Development Council, to reconsider this action.

I have lived in St. Petersburg since 2018, but before I was a resident, I was a tourist. We visited destinations throughout Pinellas County, including St. Pete Beach, Dunedin, Clearwater, and St. Petersburg before we settled here. The arts community - including great public art - was a factor in our decision to move here. Our neighborhood, Historic Kenwood, is an artist enclave.

I ask that you consider the facts about Creative Pinellas and the impact of the arts on tourism in the county.

Creative Pinellas delivers arts experiences and funding opportunities thoughtfully and efficiently through cultural tourism grants, by boosting arts communities, and showcasing our region's arts events and activities. Their galleries, programs, and artist gatherings continue to connect communities across the county with our visitors and residents with a very modest investment by the County and a rigorous internal set of financial controls.

-Of the \$94 million in bed tax revenue generated in 2024, Creative Pinellas receives 0.8% (less than 1%).

-From the County Operating Budget, Creative Pinellas receives only 0.004% of the total budget.

-Their total operating budget is \$1.78 million, with TDC funds accounting for approximately 48% of our budget.

-The share of the TDC budget that is allotted to tourism-facing salaries makes up approximately 33%.

-Their share of earned revenue is increasingly growing, and they project a 10% increase in FY2027.

Arts & culture move people beyond the beach and across the county. Five of the top twelve attractions in Pinellas County are arts destinations. Funding Creative Pinellas supports high-impact, countywide programs that residents and visitors love.

A decision to continue funding of Creative Pinellas protects a proven engine for economic impact, community well-being, and next-gen audience growth.

Objection to removing funding from Creative Pinellas

Message

The arts matter. Our community matters. And so does the work of Creative Pinellas. As the designated arts agency for Pinellas County, it drives economic growth, supports artists, and strengthens our region as an arts and cultural destination. Removing support for Creative Pinellas, as you have done and propose to do, would have a devastating impact on our community.

As a St. Pete resident and independent artist, I received a grant last year from Creative Pinellas that allowed me to achieve a long held dream of creating a dance film that I hope inspires sports audiences to support the arts and likewise: inspires artists to support local sports teams. I was

able to pay my collaborators well, which created a trickle down effect — that supported their creativity and provided potential funding for their own projects.

Artists make up a large portion of the St Pete population and Creative Pinellas goes above and beyond to support them. I felt supported financially, but also emotionally and mentally by an incredible team at Creative Pinellas. I have many friends who have been able to give back to the community through their art and art service and also realize their own dreams through direct funding from Creative Pinellas, funding which you have taken away and are taking away. In this artistic economy, no one can afford *more* funding being removed. You are pulling at threads that hold this St Pete community together at a time when togetherness is already so challenging.

This is my personal experience.

Furthermore, Creative Pinellas and Visit St. Pete/Clearwater (VSPC) have been steadily building a partnership that highlights the arts as a driver of tourism while elevating Pinellas County's reputation as a premier cultural destination.

In recent months, Creative Pinellas has been working with VSPC's team to identify their needs and develop cultural tourism programs that support the County's tourism initiatives. In fact, they are working toward a system where our two teams begin sharing visitor engagement data to better understand how the arts impacts visitor attendance, spending, and satisfaction with the destination.

Their roles are complementary, not interchangeable, and defunding Creative Pinellas weakens the foundation on which cultural tourism depends. Creative Pinellas is known as an arts destination in large part because of their work to create a thriving cultural community, and it will continue to grow and refine its efforts in the coming months and years.

Current Funding Reality: Low Draw/High Results

- Of the \$94 million in bed tax revenue generated in 2024, Creative Pinellas receives 0.8% (less than 1%).
- From the County Operating Budget, Creative Pinellas receives only 0.004% of the total budget.

These modest investments sustain the entire countywide cultural infrastructure, which in turn fuels cultural tourism and economic growth.

Please do not remove ANY funding from Creative Pinellas. If anything, you should be looking for how to INCREASE funding for this vital organization.

Dear Commissioner Scott,

I am a board member of the Clearwater Arts Alliance and a 47-year resident of Pinellas County. I feel it's critical that you reconsider your position on defunding Creative Pinellas.

- I am greatly concerned about the short notice to consider defunding Creative Pinellas, the lack of due process and the opportunity to amend the approach.
- The small savings in defunding Creative Pinellas is shortsighted in that it is not "wasted money." It is what is helping to create the experiences and the climate that visitors and residents want and enjoy. **IT IS THE PRODUCT that VSPC markets!**
- Having a **county arts agency** with which to work is big plus for Clearwater and other cities throughout the county.
- The numbers are striking: Creative Pinellas receives less than 1% of the tourism tax and only 0.001% of the county budget. That's pennies compared to the return they deliver. **Every dollar from the county is matched and multiplied by outside funding from the state, federal grants, foundations, and contracts.** In other words, county dollars unlock many more dollars that come right back to Pinellas.

- What do we get for that investment on the ground? We get neighborhoods made more vibrant with murals and art-wrapped signal boxes. We get exhibitions that showcase both youth and professional artists, in locations throughout the county—not just in one city or one gallery. **We get programming by experienced professionals that attracts visitors, supports our schools, and celebrates what makes Pinellas unique.**

The roles of VSPC and Creative Pinellas are **complimentary, not interchangeable** and defunding Creative Pinellas weakens the foundation on which cultural tourism depends. Pinellas is known nationally and internationally as an arts destination in large part because of the work of **Creative Pinellas to create a thriving cultural community.**

I urge you to reconsider your decision and protect this small but vital funding.
