# Subject:

Request for a 5-year time extension to Agreement No. 145-0317-NC (Purchasing Agreement No. 423843) for the design of a new bascule bridge to replace the existing Beckett Bridge over Whitcomb Bayou in Tarpon Springs. The existing contract with Hardesty & Hanover, LLC was originally approved by the Board on September 14, 2016.

# **Summary:**

This extension is needed to encumber the remaining funds in the contract which are needed to complete the project.

The existing contract includes post-design services to be performed during construction of the bridge. Construction has been delayed because acquisition of temporary and permanent easements has required more time than anticipated.

# Background/Explanation:

Agreement No. 145-0317-NC, Contract Purchase Agreement No. 423843 for Professional Engineering Services for Beckett Bridge Replacement, PID 001037A was approved by the Pinellas County Board of County Commissioners on September 14, 2016.

Notice to Proceed was issued on October 6, 2016.

The contract expired on October 5, 2021.

#### Fiscal Impact:

There is no fiscal impact associated with the time extension.

#### FIRST AMENDMENT

This Amendment made and entered into this <u>17th</u> day of <u>June</u>, 20<u>2</u>2 by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Hardesty & Hanover, LLC, 5110 Eisenhower Blvd, STE 310, Tampa,, FL 33634 hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

#### WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on September 14, 2016, pursuant to Pinellas County Contract No. 145-0317-NC (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Professional Engineering Services for County; and

WHEREAS, Section 23 of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a five (5) year term extension, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- 1. The term is hereby extended for an additional five (5) year period until September 14 2026.
- 2. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.
