OMB has no objection to the department submitting a grant application to the US Department of Health and Human Services, Health Resources and Services Administration, to obtain funding to expand access to mental health services, and substance abuse services focusing on the treatment, prevention, and awareness of opioid abuse.

Requested funding is \$175,000 from the Health Center Program, FY17 Access Increases in Mental Health and Substance Abuse Services Supplemental Funding Opportunity Technical Assistance. A match is not required. In the first year, \$75,000 will be used for Health IT and/or training; and \$75,000 will be used for direct services split equally among mental health and substance abuse. After year one, \$75,000 of the new money received will increase the County's base amount for the annual non-competing program continuation grant.
