Housing and Community Development (HCD) is seeking the approval of the ranking of firms with Habitat for Humanity of Pinellas County, Inc. (Habitat) as the successful bidder to purchase four County-owned parcels, execution by the Board of County Commissioners (BCC) of four deeds and acceptance and execution of the Resolution authorizing conveyance and delegating authority to the County Administrator to execute instruments necessary for completion of the transaction.

Anticipated revenue from the sale of the parcels is \$200,000 and is not included in the FY25 Operating Budget for HCD. This revenue will be placed into the Community Development Grant Fund and is anticipated to create an additional \$200,000 in unanticipated revenue. A future budget amendment would be necessary to utilize this revenue in FY25.
