WHEREAS, the **COUNTY** desires to utilize a portion of the funds available out of Pinellas

County's General Fund to assist social service agencies within Pinellas County; and

WHEREAS, the COUNTY recognizes a need for a Baker Act receiving facility and

Emergency Mental Health Services within Pinellas County; and

WHEREAS, the AGENCY is the only public crisis stabilization unit and Baker Act

receiving facility; and

WHEREAS, the AGENCY provides behavioral health services within Pinellas County and

the COUNTY recognizes that the AGENCY is providing an essential service within the

community; and

WHEREAS, the AGENCY seeks to continue implementing a Recovery Room

Intervention Model (RRIM) to promote connection to critical services and provide diversion

opportunities, where appropriate; and

WHEREAS, the AGENCY seeks to continue operating the Pinellas Integrated Care Team

pilot program.
