

**RESOLUTION NO. 17- 52**

**SUPPLEMENTING FY17 BUDGET**

**WHEREAS**, Section 129.06(2)(f), F.S., provides that unless otherwise prohibited by law, if an amendment to a budget is required for a purpose not specifically authorized in paragraphs (a)-(e), the amendment may be authorized by resolution or ordinance of the board of county commissioners adopted following a public hearing; and

**WHEREAS**, the Sewer Renewal and Replacement Fund has fund balance reserves needed to be appropriated and expended for the purpose for which received.

**WHEREAS**, the Board of County Commissioners did, on August 11, 2017, advertise the date, time, place and purpose of the Public Hearing to amend the FY17 budget pursuant to Section 129.06(2)(f), F. S., in the TAMPA BAY TIMES, a newspaper of general circulation in the County as provided herein.

**THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Pinellas County, Florida, in a public meeting duly assembled this 15th day of August, 2017, that Reserves for Future Years are to be reappropriated within the Sewer Renewal and Replacement Fund budget, within the Utilities Department, and the total County budget for FY17 as follows:


