FOURTH AMENDMENT

This Amendment is made and entered into this ______ day of ______, 2024, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Econolite Systems, Inc., hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on October 20, 2020, pursuant to Pinellas County Contract No. 189-0215-P (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Advanced Traffic Management System (ATMS), implementation and maintenance for the County; and

WHEREAS, Section twenty-one (21) of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for additional funds and a term extension, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- The Parties agree to extend the term of the Agreement an additional year from July 1,
 2024, to June 30, 2025, for maintenance and support services.
- 2. Section five (5) ("Compensation and Method of Payment"), subsection A, is revised to reflect an increase in the amount of \$51,300.00 to the total agreed upon total of \$1,819,983.42, for a new total not-to-exceed expenditure of \$1,871,283.42.
- Except as changed or modified herein, all provisions and conditions of the original
 Agreement and any amendments thereto shall remain in full force and effect.
