# Dear County Commissioners:

Just some thoughts on the over-water portion of the Pier District. The design, as it now stands, is mediocre at best...even with an additional \$14M for enhancements. The attached photo, while somewhat tongue-in-cheek, is basically what we are buying, a fancy Santa Monica Beach lifeguard shack..

The Echelman sculpture, if feasible, is what will draw tourists...like "The Bean" sculpture in Chicago's Millennium Park. The over-water Pier, as currently configured, is a huge waste of funds that could be better spent on the landslide portion of the Pier District.

Please consider simplifying the over-water attraction. A walking/fishing path out to a simple, but attractive, 2-story building. On the first floor vendors of LOCAL food and beverage offerings, for example:

- · Kahwa Coffee
- Tropicool or Paciugo ice-cream
- Engine #9 burgers
- Mazzaro's sandwiches and deli offerings
- Green Bench or 3 Daughters craft beer
- City souvenir shop (like the Chamber shop)
- · Etc.

Put the savings into the landslide portion of the 26-acre Pier District. If the over-water portion is simplified, it is likely you won't need the extra \$14M, and the annual subsidy likely wouldn't soar to \$1.9M, a \$500,000 increase over the pyramid's subsidy. You could have some subsidy in the form of below-market rents at the Pier head (not on the landslide portion) to attract the small, local vendors you want.

The second floor can be an observation area with wrap-around balcony and an event/meeting room inside (with a bar area and catering kitchen) for weddings, class reunions, business retreats, etc. This space could be rented


by the City, so long as it is predominately for use by the public (say 75-80% of the time). The walls can show off the work of local artists...and make them available for sale, with the city getting a "gallery commission" on sales. The roof could house a solar array to provide power for the building.

I hope my comments about simplification and avoiding the need for additional funds will be considered. Let's put money into something that will attract tourists (Echelman sculpture) and into the part of the Pier District that will get the most use (landslide). Use the Pier head to showcase some of our local food, drink, art, and views of the Bay and Downtown Skyline.
