The Pinellas County Board of County Commissioners proposes to adopt the following Ordinances and Resolutions amending the Pinellas County Future Land Use Map, Zoning Atlas, a Development Master Plan, and the Comprehensive Plan.

A public hearing on the Ordinances and Resolutions with virtual public participation and an on-site participation option, to be held on Tuesday, October 25, 2022, at 6:00 P.M. or thereafter in the County Corminission Assembly Room, Fifth Floor, Pinellas County Courthouse, 315 Court Street, Clearwater, Florida 33756, with virtual participation utilizing Communications Media Technology (CMT) on the Zoon platform.

Members of the public wishing to address the body may attend in person, attend virtually or provide comments in advance.


