

**PINELLAS COUNTY HEALTH CARE PROGRAM**  
**INTERLOCAL AGREEMENT**  
**AMENDMENT NO. 1**

AMENDMENT NO. 1 is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2016, by and between **PINELLAS COUNTY**, a political subdivision of the State of Florida, hereinafter called the “**COUNTY**” and the **FLORIDA DEPARTMENT OF HEALTH**, an agency of the State of Florida providing public health services in Pinellas County, hereinafter called “**DOH PINELLAS.**”

**WITNESSETH:**

**WHEREAS**, the **COUNTY** desires to increase access to health and behavioral health care for low-income uninsured residents of Pinellas County through the Pinellas County Health Program which includes the Healthcare for the Homeless (HCH) program, a Federally Qualified Health Center funded in part by the U.S. Health Resources and Services Administration (HRSA); and

**WHEREAS**, the **COUNTY** recently applied for and was awarded additional funding from HRSA for Expanded Services for the HCH; and

**WHEREAS**, the **COUNTY** was notified by HRSA of an additional award for Quality Improvement for the HCH; and

**WHEREAS**, the **COUNTY** was notified by HRSA of an increase in Base Funding for the HCH; and

**WHEREAS, DOH PINELLAS** and the **COUNTY** wish to utilize county funding and Base Funding increases from HRSA to support expenditures for dental laboratory expenditures for a pilot denture program during the term of this Agreement; and

**WHEREAS,** the **COUNTY** recently applied for and was notified that funding from the State of Florida Agency for Health Care Administration (AHCA) for Community & Primary Care Services would be available to increase access to primary care services in the HCH. This funding is also intended to prevent unnecessary emergency room visits and inpatient hospitalization for homeless individuals with behavioral health challenges; and

**NOW, THEREFORE,** in consideration of the mutual covenants contained herein, the parties agree as follows:

1. **Section 4. Compensation** is amended to read as follows:

The compensation provided for under this Agreement shall be for a total amount not to exceed Eleven Million, Five Hundred Forty Thousand, Seven Hundred Eighty Eight Dollars (\$11,540,788.00) for the term of this Agreement. Amendment No. 1 adds a total of Seven Hundred Forty-Six Thousand, Three Hundred Five Dollars (\$746,305.00) in new grant funding to the Agreement (see Attachment 1- Revised Budget.) Of this amount, two hundred ninety-four thousand two hundred nineteen dollars (\$294,219.00) is contingent upon receipt of funding from AHCA per the grant proposal submitted in September 2015.

2. **Section 9. Dental Services** is amended to read as follows:

**DOH PINELLAS** shall provide comprehensive dental services to adults enrolled in the PCHP/MMU at the closest medical homes that provide this service. Services include preventive and relief of pain services including dental exam, oral cancer screenings, oral health education, dental X-rays, cleaning, extractions, restorations, incisions, drainage, and prescriptions. In addition, a pilot denture program will be provided for approximately one hundred eighty (180) individuals during the term of this Agreement.

**3. Section 15. Mobile Medical Unit and Safe Harbor Shelter Operations.**

Section 15 a) and b) are amended to read as follows:

- a) The MMU team will consist of 2.0 FTE nurses, 1.0 FTE senior physician, .8 FTE supervisor/ case manager, and 2.0 FTE driver/ support staff.
- b) The Safe Harbor Shelter team will consist of 1.5 FTE medical examiner (Physician Assistant, ARNP or MD), 1.0 FTE senior clerk, 1.0 FTE medical assistant, .2 FTE supervisor, 1.5 FTE case manager, 2.5 FTE nurse, .8 FTE social worker, .5 FTE eligibility specialist and 1.0 FTE Care Coordinator. Funding added pursuant to the HRSA Expanded Services award supports staff and expenses for evening and weekend hours at the Safe Harbor Shelter. Funding added pursuant to the AHCA award supports mobile behavioral health services and additional staff at Safe Harbor Shelter through June 30, 2016.

**4. Section 17. PCHP Services.**

Section 17 is amended to add section g) as follows:

g) Pursuant to the HRSA 2015 Quality Improvement Award, 2.5 FTE Quality Improvement (QI) personnel will develop and improve QI care delivery systems and infrastructure. New staff includes 1.0 FTE Community Health Advocate, 1.0 FTE Human Services Analyst, and .5 Computer Program Analyst. The QI staff is supported through the QI award through August 17, 2016.

5. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect.
