# **NOTICE OF PUBLIC HEARING OF A PROPOSED ORDINANCE AMENDING THE PINELLAS COUNTY CODE**

The Pinellas County Board of County Commissioners proposes to adopt the following Ordinance amending the Pinellas County Code.

A public hearing on the Ordinance with virtual public participation and an on-site participation option will be held on **Tuesday, July 30, 2024, at 6:00 P.M.** or thereafter in the Palm Room, 333 Chestnut Street, Clearwater, Florida 33756, with virtual participation utilizing Communications Media Technology (CMT) on the Zoom platform.

The public hearing will be streamed live at <https://youtube.com/pcctv1> and [www.pinellas.gov/TV](http://www.pinellas.gov/TV), and broadcast on the Pinellas County cable public access channels:

Members of the public wishing to address the body may attend in person, attend virtually, or provide comments in advance.

To address the County Commission in person, members of the public are encouraged to preregister at [pinellas.gov/comment](http://pinellas.gov/comment). Preregistration is encouraged but not required if individuals plan to attend the meeting in the Palm Room. Those who have not preregistered may register when they arrive.

**Members of the public wishing to address the body virtually via Zoom or by phone are required to preregister by 5:00 P.M. the day before the meeting** by visiting [pinellas.gov/comment](http://pinellas.gov/comment). The registration form requires full name, address and telephone number if joining by phone, along with the topic or agenda item to be addressed. ## **A. PROPOSED ORDINANCE TO AMEND THE PINELLAS COUNTY CODE:**

AN ORDINANCE OF THE COUNTY OF PINELLAS RELATED TO AD VALOREM TAX EXEMPTION; AMENDING CHAPTER 118 TO CREATE A NEW ARTICLE VIII; ADDITIONAL HOMESTEAD EXEMPTION FOR QUALIFYING LIVING QUARTERS OF PARENTS OR GRANDPARENTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AREAS EMBRACED; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR CORRECTION OF SCRIVENER'S ERRORS; AND PROVIDING FOR AN EFFECTIVE DATE.
