Kelli,

The damage survey report (DSR) covering the debris removal for the Pinellas County EWP related to Hurricane Milton has been approved and funded. The estimated construction cost is \$5,426,045.00. NRCS will reimburse for 100% of the construction cost (not to exceed \$5,426,045.00) and also 10% of the construction cost (not to exceed \$542,604.50) for technical services items such as survey, design, contract administration, and inspection. The DSR's for bank stabilization have not been approved yet. We are working on those.

The Emergency Watershed Protection (EWP) program operates via a cooperative agreement between NRCS and the sponsor, where the sponsor administers the agreement and manages the work. In order to start preparing the agreement, I need the following items completed and returned to me:

- SF-424 (Application for Federal Assistance) – I have entered the correct budget numbers in Section 18 already. Yellow cells are required cells.
- SF-424D
- Certification Regarding Lobbying
- FPAC-GAD-9 (sponsor's points of contact)

Signatures on these documents need to be either a hand signature that is scanned or an electronic signature with an appropriate certificate.

Also, as a sponsor, you need to be registered with [sam.gov](https://sam.gov) and have a unique entity identifier (UEI).
