You are being notified of this action because Pinellas County and the Pinellas Planning Council are affected parties. These annexations are being initiated in accordance with Chapter 171 of the Florida Statute.

This annexation is in compliance with both the Interlocal Agreement, dated July 2000, between Largo, Pinellas County and Pinellas Park, and the Settlement Agreement between all the Cities of Pinellas County, Florida, for the Resolution of Issues related to the Charter Review Committee, dated May 2007.

Enclosed is a copy of the Notice of Public Hearing, for Ordinance Numbers 202-49 -2025-51 and 2024-56 will be published in the Tampa Bay Times, Neighborhood Times, Section on Wednesday, June 19th, 2024, and on Wednesday, June 26, 2024. **First reading for the Ordinances is scheduled for June 18th, 2024. The Public Hearing has been scheduled for Tuesday, July 16th, 2024.** Meetings are held at the Largo City Hall, 201 Highland Avenue, at 6:00pm.

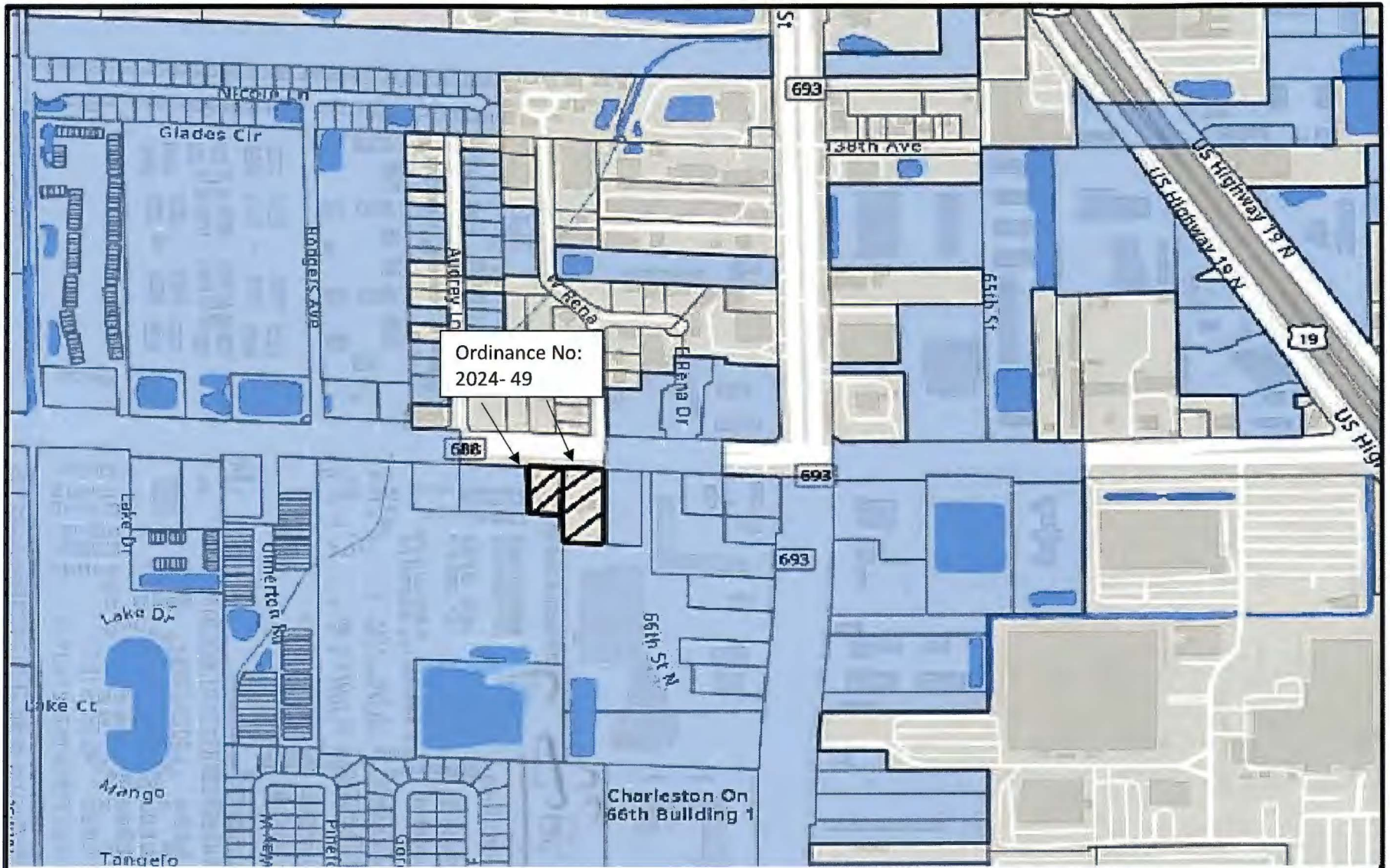

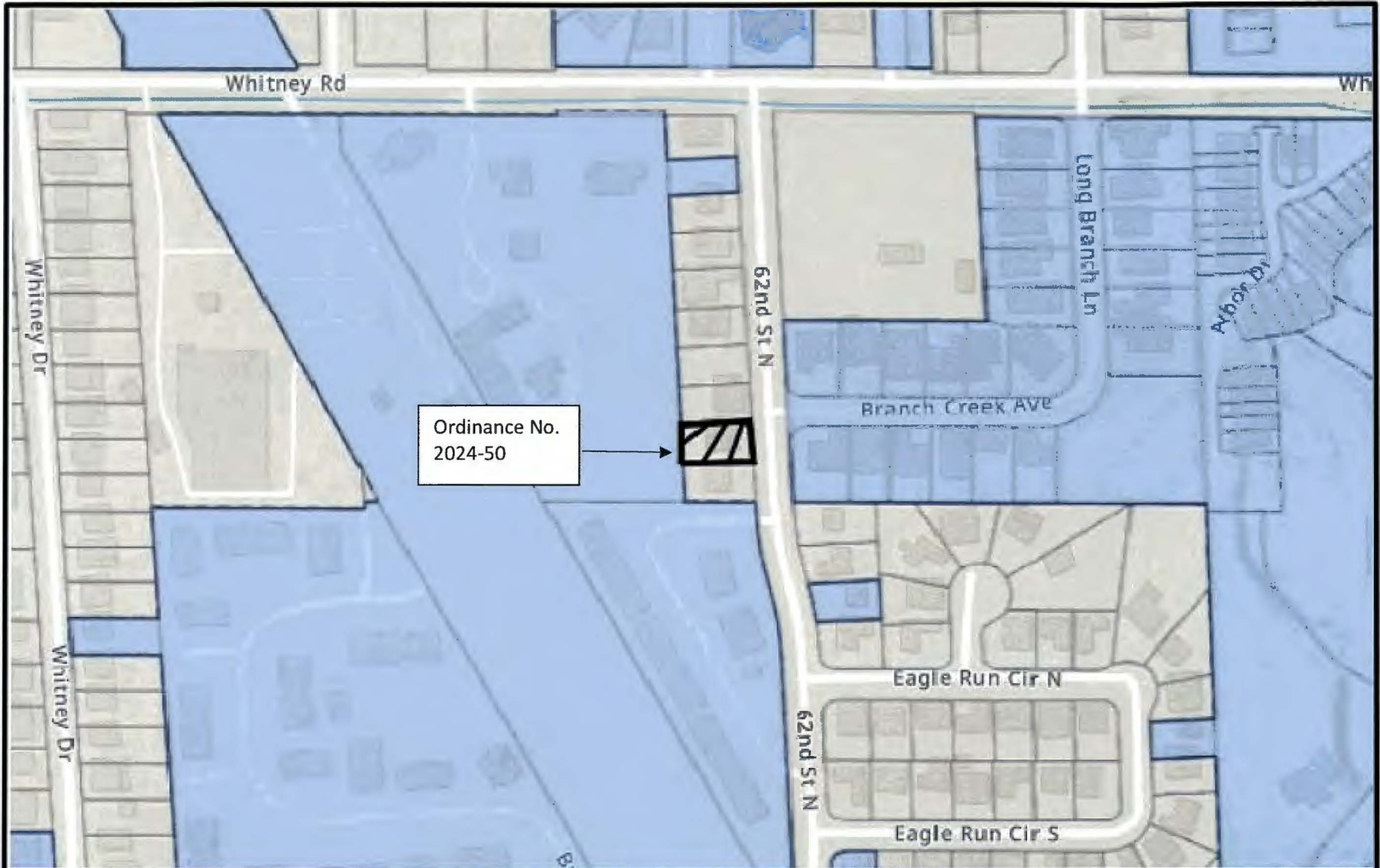

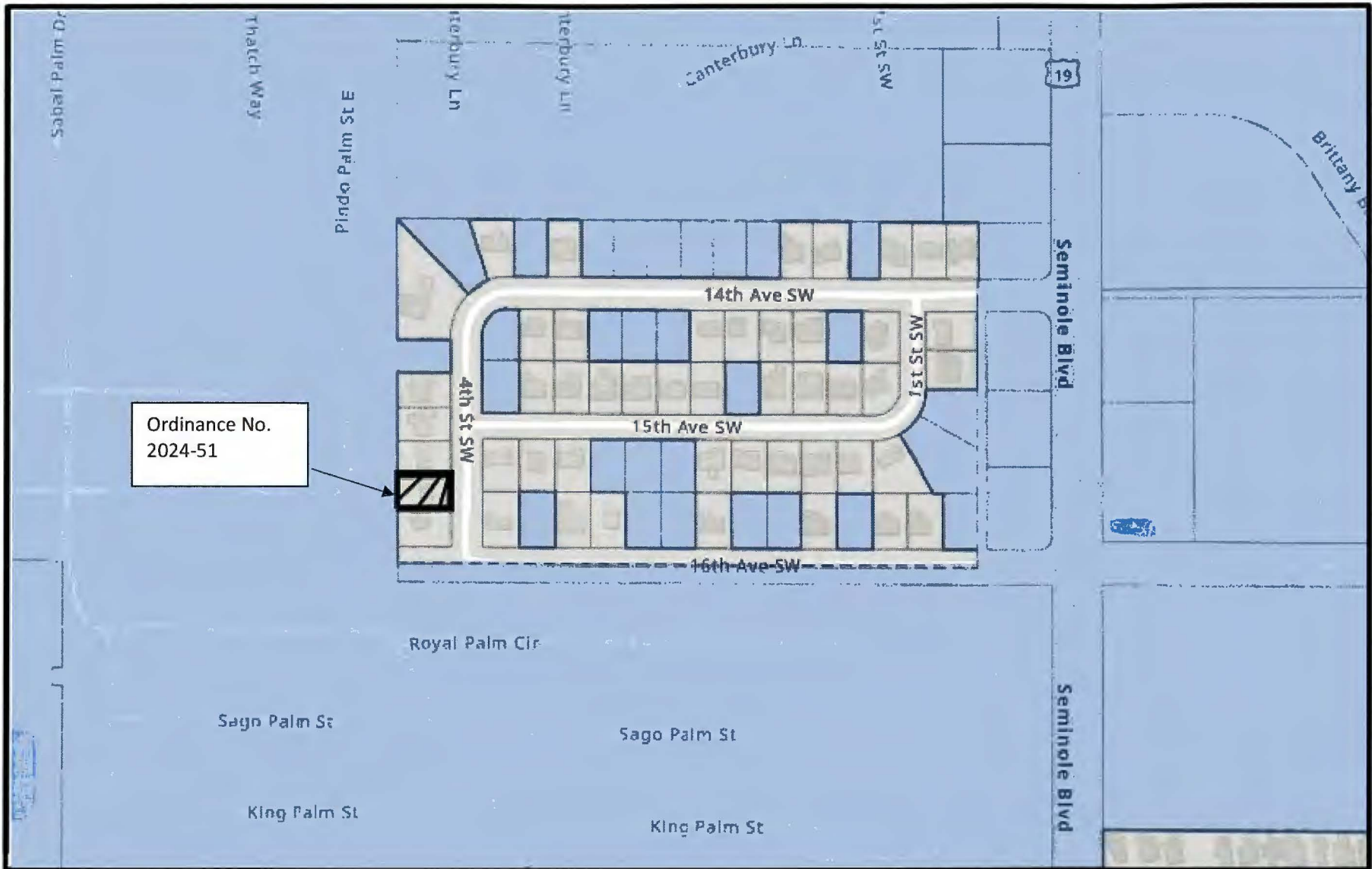



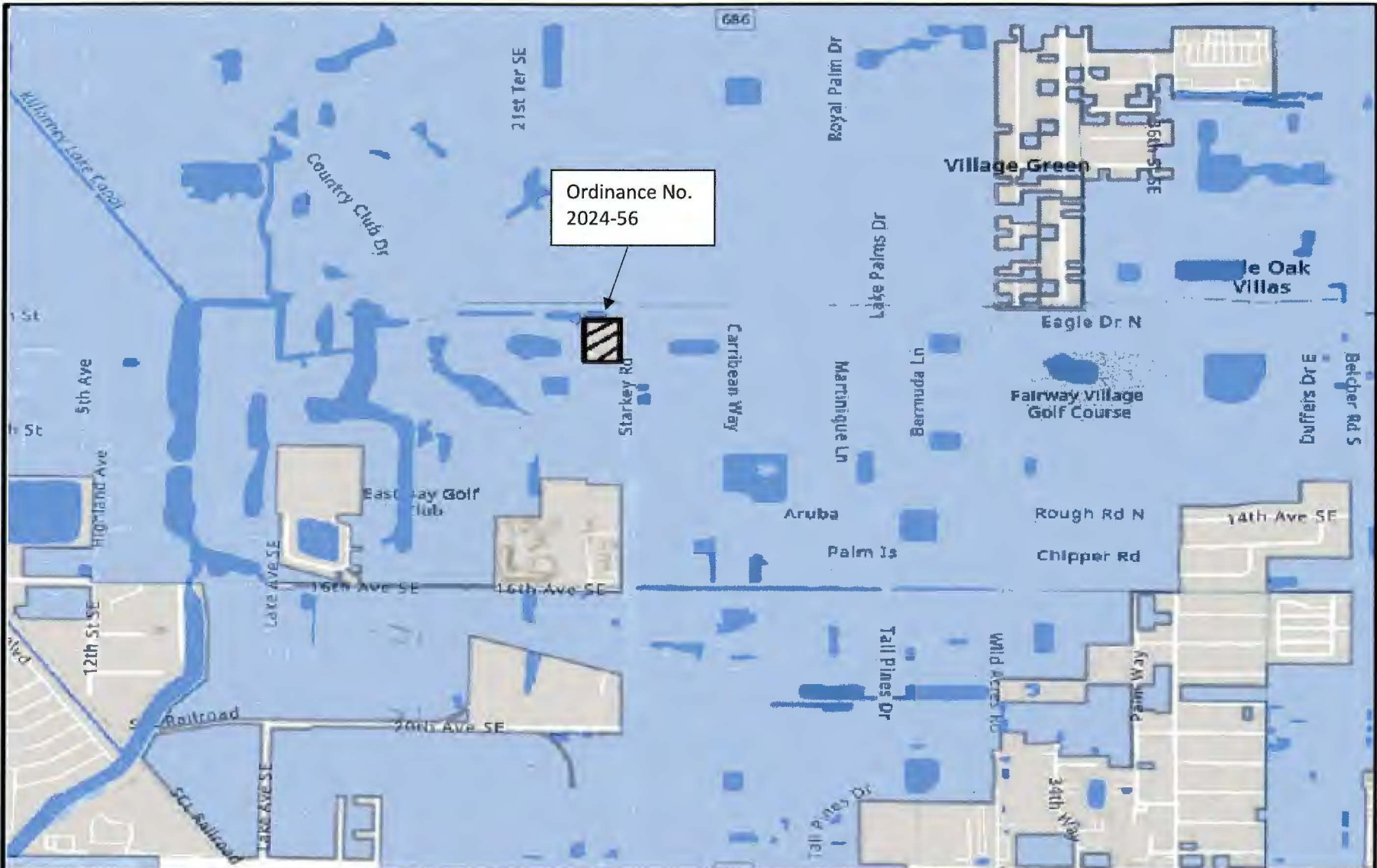
