WITNESSETH





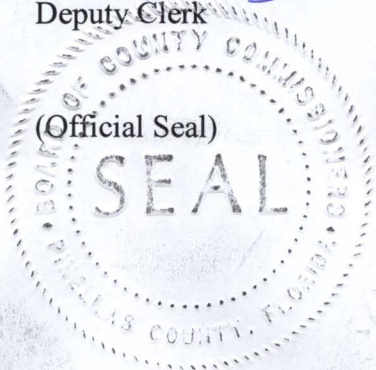
