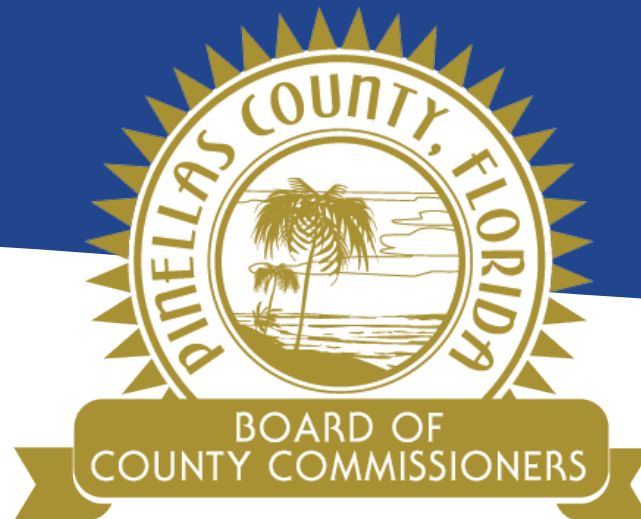

Maximum Millage Rates



- **Counties must establish maximum millage rates for certification to the Property Appraiser by August 2 each year [F.S. 200.065(2)b]**
 - **Millage Rates may be decreased after certification**
 - **The Maximum Millage Rates will be included in TRIM Notices**
 - **The Millage Rate is the rate applied to a property's taxable value to determine property tax due - the rate expresses the dollars of tax per one thousand dollars of taxable value (a 5.0 mill tax on \$1,000 equals \$5.00)**

Budget Timeline



- **August 2nd – maximum millages sent to the Property Appraiser**
- **August 21st – TRIM notices mailed to all property owners**
- **September 7th – 1st Public Hearing**
- **September 19th – 2nd Public Hearing**
- **October 1st – Fiscal Year 2024 begins**
