

RESOLUTION NO. 22-42

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA APPROVING THE ISSUANCE OF NOT TO EXCEED \$5,000,000 PINELLAS COUNTY EDUCATIONAL FACILITIES AUTHORITY REVENUE BONDS (ACADEMIE DA VINCI CHARTER SCHOOL FOR THE ARTS AND TECHNOLOGY PROJECT), SERIES 2022 PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986; PROVIDING CERTAIN OTHER MATTERS IN CONNECTION THEREWITH; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Pinellas County, Florida (the "Board"), adopted on October 11, 1977, Resolution No. 77-601, as amended and supplemented by Resolution 94-296 and Resolution 99-215 (collectively, the "Resolution"), creating the Pinellas County Educational Facilities Authority (the "Authority"); and

WHEREAS, the Authority is, pursuant to the Resolution, empowered to issue its revenue bonds, and the interest on such revenue bonds is able to be excluded from gross income for federal income tax purposes, with such revenue bonds being issued for the purpose of providing financing for structures suitable for use as educational facilities, and other structures or facilities related thereto which are to be owned by nonprofit educational providers and the proceeds of such revenue bonds may also be used for equipment and other similar items necessary or convenient for the operation of a particular facility pursuant to Chapter 243, Part I and Chapter 159, Part II, Florida Statutes; and

WHEREAS, Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), requires as a condition of exclusion from gross income for federal income tax purposes of the interest on private activity revenue bonds, that the issuance of private activity bonds, as defined in Section 141(a) of the Code, such as the Pinellas County Educational Facilities Authority Revenue Bonds (Academie Da Vinci Charter School for the Arts and Technology Project), Series 2022 (the "Bonds") be approved, after a public hearing following reasonable public notice, by the governmental unit on behalf of which such obligation is to be issued and the governmental unit having jurisdiction over the area in which the private activity bond-financed facility is to be located; and

WHEREAS, the Authority issues its revenue bonds on behalf of Pinellas County, Florida, and the Project (as defined herein) to be financed and refinanced with the proceeds of the Bonds, is located at 1060 Keene Road, Dunedin, Florida, 34698, which is in Pinellas County, Florida, and the Board constitutes the elected legislative body of Pinellas County, Florida; and

WHEREAS, the Authority has requested the Board, pursuant to Section 147(f) of the Code, approve the issuance by the Authority of its Bonds in an amount not to exceed \$5,000,000; and

WHEREAS, the Board posted a notice of a public hearing at least seven (7) days prior to the date of such public hearing on the County's website, which notice remained posted through the date of the public hearing, which is being held at this meeting, in the County Commission 5th Floor Assembly Room, 315 Court Street, Clearwater Florida 33756, to consider the issuance of the Bonds and the location and nature of the Project to be financed and refinanced with the proceeds of the Bonds; and

WHEREAS, the public hearing so noticed, as herein indicated was posted on the County's website at least seven (7) days prior to the date of such public hearing in the form attached hereto as Exhibit A, and was duly held on this day; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA:

Section 1. The issuance by the Authority of its not to exceed \$5,000,000 Pinellas County Educational Facilities Authority Revenue Bonds (Academie Da Vinci Charter School for the Arts and Technology Project), Series 2022, on behalf of Academie Da Vinci Charter School, Inc., (the "Borrower") for the purpose of (i) the refinancing of certain existing indebtedness of the Borrower, the proceeds of which were applied to the acquisition, construction, improving and equipping of the Borrower's existing facility which currently accommodates approximately 350 students, with a maximum capacity of 364 students, in grades kindergarten through eighth, located at 1060 Keene Road, Dunedin, Florida 34698, including related facilities, fixtures, real property, furnishings and equipment; (ii) the acquisition, construction and equipping of improvements to the Borrower's playground and related facilities; and (iii) the payment of certain costs of issuance of the Bonds (collectively, the "Project") is hereby approved pursuant to and in accordance with Section 147(f) of the Code.

Section 2. This resolution shall take effect immediately upon its adoption.

## EXHIBIT A

### FORM OF TEFRA NOTICE

#### NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Pinellas County, Florida will consider the approval of one or more series of revenue bonds, either tax-exempt, or taxable, or both, to be issued by the Pinellas County Educational Facilities Authority (the "Issuer"), in the aggregate principal amount of not to exceed \$5,000,000 (the "Bonds") on behalf of Academie Da Vinci Charter School, Inc., a Florida not for profit corporation, (the "School"). The School currently owns and operates its facilities, which are comprised of two existing buildings with a total of approximately 28,000 square feet, to accommodate approximately 350 students, with a maximum capacity of 364 students, in grades kindergarten through eighth, including related facilities, fixtures, real property, furnishings and equipment, known as Academie Da Vinci Charter School, located at 1060 Keene Road, Dunedin, Florida (the "Educational Facility").

The proceeds of such bond issue will be used by the School for the purpose of financing or refinancing, including through reimbursement, (i) the refinancing of certain existing indebtedness of the School, the proceeds of which were applied to the acquisition, construction, improving and equipping of the Educational Facility, (ii) the acquisition, construction and equipping of improvements to the School's playground and related facilities; and (iii) the payment of certain costs of issuing the Bonds (collectively, the "Project"). The Project will be owned by the School.

This notice is provided for a public hearing to be held regarding the nature and location of the Project at a meeting on May 24, 2022, beginning at 6:00 p.m., or as soon thereafter as may be heard, in the County Commission 5th Floor Assembly Room, 315 Court Street, Clearwater Florida 33756. As an alternative to attending in person, the Issuer also provides for virtual participation utilizing Communications Media Technology (CMT) on the Zoom platform.

THE BONDS WILL NOT CONSTITUTE A DEBT OF THE STATE OF FLORIDA, THE SCHOOL DISTRICT OF PINELLAS COUNTY, FLORIDA, PINELLAS COUNTY, OR ANY POLITICAL SUBDIVISION THEREOF, but will be payable solely from payments made by the School.

The hearing is being held for the purpose of affording residents of Pinellas County, Florida and other interested persons an opportunity to express their views, both orally and in writing, on the proposed issuance of the Bonds and the nature and location of the Project.
