

RESOLUTION NO. 19- 98

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA, SUPPLEMENTING RESOLUTION 10-198; DESIGNATING CERTAIN PINELLAS COUNTY CODE ENFORCEMENT PERSONNEL SUPPORTING THE CONSTRUCTION LICENSING BOARD TO ENFORCE CHAPTER 75-489 LAWS OF FLORIDA (SPECIAL ACT), AS AMENDED AND COUNTY CODES AND REGULATIONS PURSUANT TO CHAPTER 125, CHAPTER 162, AND CHAPTER 705 OF THE FLORIDA STATUTES; PROVIDING FOR PUBLIC RECORDS EXEMPTIONS FOR CURRENT AND FORMER CODE ENFORCEMENT OFFICERS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 75-489 Laws of Florida, as amended, authorizes the Pinellas County Construction Licensing Board (PCCLB) to issue citations for contracting violations; and

WHEREAS, the PCCLB issues citations through employees of the County;

WHEREAS, Section 125.69, Florida Statutes, authorizes counties in the State of Florida to impose fines or imprisonment for violations of ordinances and to provide for enforcement of its ordinances by code inspectors; and

WHEREAS, Chapter 162, Florida Statutes, permits designated code inspectors to request hearings and ensure code compliance pursuant to said chapter; and

WHEREAS, Chapter 705, Florida Statutes, authorizes counties to designate employees who have the authority to enforce codes or ordinances to administer the provisions of said Chapter; and

WHEREAS, the Pinellas County Construction Licensing Board supports the designation of certain code enforcement officers and employees; and

WHEREAS, Section 119.071(4)(d)2.i, Florida Statutes, provides additional public records exemptions for personal information of current and former code enforcement officers.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA, in meeting duly-assembled on this the 10 day of December, 2019, that:

Section 1. This Resolution supplements Resolution No. 10-198.

Section 2. Certain agents or employees of the County holding the positions identified below are acting on behalf of the County and the Pinellas County Construction Licensing Board with authority to issue citations for violations of County ordinances in accordance with the provisions of chapter 75-489 Laws of Florida, as amended, and are additionally authorized to issue citations for violations of County ordinances in accordance with the provisions of Section 125.69, Florida Statutes, as amended; and code inspectors as defined in Section 162.04, Florida Statutes, as amended; and as code inspectors and code enforcement officers pursuant to Chapter 705, Florida Statutes, as amended, should such enforcement duties be assigned:
