## **Economic Development**

**19.** Resolution expressing support of C1012942751 as a qualified applicant for an Economic Development Ad Valorem Tax Exemption.

Resolution No. 21-29 adopted supporting C1012942751 as a qualified applicant pursuant to Section 196.1995, Florida Statutes, and authorizing the company to make improvements before an exemption ordinance is adopted.

Economic Development Business Development Division Director Suzanne Christman disclosed that the applicant is the Halkey-Roberts Corporation; that the company is considering an expansion of their St. Petersburg facility; and that the County is competing with locations in Alabama and Texas.

Responding to queries by Chair Eggers and Commissioner Peters, Ms. Christman indicated that approval of today's request would allow the company to move forward in the decision-making process for the project; that once the project has started, the company will submit an application for a tax exemption which will contain a fiscal impact study completed by the Property Appraiser's Office; and that Halkey-Roberts anticipates the creation of more than ten new jobs resulting from the project.

Commissioner Flowers thanked Chair Eggers for requesting additional information from the company and noted the competitiveness of the request. She related that manufacturing jobs will allow for continued economic growth; and that when additional financial data is received, a better projection of the expansion outcomes will be available.

Ms. Christman confirmed that the eventual tax exemption request would be for the added building only.

## **Housing & Community Development**

Agreement approved, replacing the existing Interlocal Agreement executed on May 19, 2015. The Agreement will remain in full force and effect until terminated by either party and will be reviewed every ten years to address updates and amendments, as needed.

In response to a query by Commissioner Seel, Community Development Manager Bruce Bussey indicated that the revised Agreement contains specifications regarding payments per project and the addition of guidelines regarding use of Penny IV funds; and that the Agreement does not alter the administrative duties currently being performed by the Housing Finance Authority.

Proposed resolution making a finding that conditions of blight exist in the North Greenwood study area, establishing the Community Redevelopment Area boundary, authorizing the preparation of the North Greenwood Redevelopment Plan, and delegating redevelopment authority to the City of Clearwater.

Public hearing held and Resolution No. 21-30 adopted finding that conditions of blight exist as defined in the Community Redevelopment Act of 1969, approving the establishment of area boundaries, authorizing the preparation of the redevelopment plan, and delegating certain power and authority to the City of Clearwater as the agency for the North Greenwood Community Redevelopment Area.

Planning Division Manager Evan Johnson related that County staff has continued to work with the City of Clearwater regarding the North Greenwood study area and conducted a review of the Finding of Necessity; that approval of the resolution will allow the City to begin the planning process for the CRA; and that any tax increment financing will be discussed and scored once the Redevelopment Plan is completed.

Notice of grant award approved providing one-time funding to support preparation, detection, and response to the COVID-19 pandemic; funding is in the amount of \$1,567,250.00 for a two-year period of performance from April 1, 2021 through March 31, 2023. No County match required. The Health Care for the Homeless Governing Board will accept the grant award on April 13, 2021.

County Administrator Barry Burton introduced the item, indicating that the Florida Department of Health and the Health Care for the Homeless Co-Applicant Governing Board will be making guidelines regarding the use of the funds; whereupon, in response to a query by Chair Eggers, Interim Director of Human Services Karen Yatchum stated that primary health care would be provided to the homeless even without the grant; and that the grant will expand the availability of street medicine by bringing primary health care directly to those living on the streets.

## CareerSource Pinellas

## Housing Finance Authority

**26.** Resolution approving the issuance of Multifamily Housing Revenue Bonds by the Housing Finance Authority of Pinellas County to finance the acquisition and rehabilitation of Palmetto Park Apartments.

Resolution No. 21-31 adopted approving the issuance of bonds in a principal amount not to exceed \$14,250,000.00 for the benefit of Palmetto Preservation, Ltd, a Florida Limited Partnership. No County General Funds are required; all lendable funds are generated from the sale of tax-exempt housing bonds and the sale of low-income housing tax credits from the Florida Housing Finance Corporation.

Mr. Burton introduced the item, indicating that the funds will be used to rehabilitate 179 units of family rental housing, comprising of 16 units set aside for households at or below 30% area median income (AMI), 144 units at or below 60% AMI; and 19 units at or below 80% AMI.

In response to queries by the members, Pinellas County Housing Finance Authority Executive Director Kathryn Driver clarified that there is a mixture of income levels within the complex; that the units are fully occupied; and that tenants will not be required to move out during the rehabilitation of the apartments.

Referring to the creation of a Redistricting Board, Attorney White indicated that a consultant has been hired by the County to help with the redistricting process; that appointments to the Board will be made at the August 10 Commission meeting; and that the first meeting of the Board will likely occur on September 1; whereupon, she explained the redistricting process generally.

- Request for Enlargement of Time for Case Z/LU-14-09-19

Referring to the upcoming May 25 public hearing on Case No. Z/LU-14-09-19, Attorney White indicated that the applicant's representative, Joel Tew, has requested an enlargement of time to 45 minutes to present his case. She provided background information related to the case and recommended that if the Board decides to grant the enlargement of time, the Board should also grant the same amount of time to County staff; whereupon, she indicated that although the public hearing on May 25 is specifically addressing the land use designation and not the zoning, the Commission will see background materials related to both zoning and land use within the underlying case record.

In response to a query by Commissioner Seel, Attorney White clarified that approval of the project is a two-step process, with the first step being a determination at the Board's May 25 public hearing regarding whether to transmit the land use amendment to the State Land Planning Agency (Florida Department of Economic Opportunity) for comments and the second step being a public hearing in August on the proposed zoning change. Referring to the request for the enlargement of time, she explained that a similar request was granted for the applicant at the April 6, 2021 Local Planning Agency hearing; whereupon, discussion ensued regarding the following topics:

- Public participation in the hearing
- Limiting the length of other topics on the May 25 meeting agenda
- · Other public hearings on the agenda
- · Protocols for speaking on behalf of a group of individuals

## **29.** County Administrator Reports:

- Spring Break Snapshot
- St. Petersburg/Clearwater Area Convention and Visitors Bureau Update

Mr. Burton introduced Convention and Visitors Bureau President and CEO Steve Hayes; whereupon, Mr. Hayes provided the Board with an update regarding tourism in the county and discussed COVID-19 impacts on occupancy rates, tourist development tax collections, and tourism generally. He highlighted that 2021 statistics are on track to meet or exceed 2019 statistics.

Mr. Hayes provided his input regarding the future of tourism in 2021, relating that in a recent study, 84% of individuals indicated that they would travel between the months of April and December; that vacation rental bookings are on track to exceed bookings in 2019; that there may not be a lull in individuals traveling between the spring and summer seasons; and that tourism in the summer of 2021 is expected to exceed previous years' tourism numbers.

Mr. Hayes provided information regarding the Rise to Shine campaign, which is a public relations effort to educate visitors about traveling safely and responsibly during COVID-19, indicating that the campaign was promoted through a variety of sources including television and radio; and that the campaign garnered attention from national news sources.

In response to queries by Commissioner Justice, Mr. Hayes described the status of international travel to and from Pinellas County, related that international and business travel has declined due to COVID-19, and provided information related to marketing efforts in the mid to lower Midwest and the Northeast.

- Upcoming Budget Information Sessions

Mr. Burton reminded the Commissioners that budget information sessions will be conducted in May and June, indicating that the final budget will reflect a prioritization of the various needs within the County. In response to comments by the Commissioners, Mr. Burton stated that he would ask staff to explore alternative formats and locations for future work sessions for when the Board of County Commissioners is no longer using the Magnolia Room for meetings.
