Despite over 70 percent of the case-patient participants' efforts to follow CDC recommendations by committing to always wearing face coverings at "gatherings with $\leq 10$ or >10 persons in a home; shopping; dining at a restaurant; going to an office setting, salon, gym, bar/coffee shop, or church/religious gathering; or using public transportation," they still contracted the virus. While the study notes that some of these people may have contracted the virus from the few moments that they removed their mask to eat or drink at "places that offer on-site eating or drinking," the CDC concedes that there is no successful way to evaluate if that was the exact moment someone became exposed and contracted the virus. "Characterization of community exposures can be difficult to assess when widespread transmission is occurring, especially from asymptomatic persons within inherently interconnected communities," the report states



Obviously the prudent approach was adopted by the Swedes. Their success is actively being suppressed by the media as well as the medical elite for two reasons.


