Dear Commissioners Peters, Scott, Long, Justice, Eggers, Latvala, and Flowers -

I write to you as an individual with no connection to the Tampa Bay Rays or anyone involved in the development project. I have been a resident of Pinellas County since 2016.

After many years of painstaking work between the Rays, St. Petersburg, and Pinellas County, all parties committed to a transformational development project for the entire region.

Pinellas should respect the judgment of the prior Commission, and approve the bond issue, especially since there has been no material change in the plan.

The Tampa Bay Times has quoted Commissioners raising issues such as

- Unhappiness that the Rays are playing the 2025 season outside of Pinellas County - the Pinellas facilities don't have sufficient seating and will require costly upgrades to meet the standards required by MLB and the MLB Players Association.
- The cost of Helene and Milton remediation has changed the County's ability to fund their portion - Helene and Milton remediation costs are insignificant in the context of the total revenues and costs over the next 30 years.

There are also financial downsides if the development halted.

Finally, there is the broader issue of Pinellas County no longer being considered a reliable partner for future development opportunities. We all know that competing development agencies will emphasize this point, which I think will resonate powerfully with investors considering Pinellas County locations among others.

Please do not let a generational development opportunity for Pinellas County, St. Pete, and the broader region slip through your fingers.

Dear Pinellas County Commissioners

First and foremost, I want to applaud you all for your support of the new Rays Stadium. What an exciting time for the region! While I do not live in the area, I can assure you that the existence of the Rays fosters many visits to the region, including that of restaurants, hotels, theme parks, etc...by those of us in SW Florida.

We are certainly familiar with hurricanes, even more so than that of your region as Lee County Florida has had many challenges with storms. The latest tragedy in the damage to the Trop is awful. Its magnitude is large I would agree, but nothing compared to that of Hurricane Ian and the damages occurring on our coastal islands, mainland infrastructure, and along out inner coastal waterways. It took courage for our local government to take on this challenge along with state and federal authorities.

Now Pinellas County is faced with a huge challenge in their recent efforts to keep MLB baseball in the region. As a season ticket holder of several tickets, and a business that has sponsored the Rays in the past (Fantastic Sams), I can explicitly say that the region receives many travelers from our neck of the woods due to MLB baseball. In fact, I would go as far as to say, the region becomes much less important without MLB baseball. For the Rays and Pinellas County to stay competitive for the entertainment dollars in this region, they must continue to support the new stadium. The history, demographics, and financial outcome clearly shows the value of an MLB franchise in the cities they reside in.

On a personal note, last year it looks like my family spent about 28K in trips to the Tampa region, and all but one of them were associated with the Rays game also. Examples would be to visit a museum before a game, visiting restaurants before games. A night or two stay to watch a couple of games, always in hotels, followed by shopping, etc...I am asking for your continued support of the new stadium and recognize the extremely difficult task of having to play elsewhere while this gets resolved. In my opinion, it is a waste of money to spend any money on the Trop and simply get it down to make the build easier. I am sure there is much more to it then this, but I hate to see any capital waste for anyone, really does not matter who is paying the bill.

A contract was signed by the Tampa Bay Rays, the City of St Petersburg, and your body, the Pinellas County Commission in July, and if we want to be taken seriously as a high-quality business partner not just for Major League Baseball but for Jabil, Raymond James, Foot Locker, and other Fortune 1000 companies looking to stay in or move to Pinellas County, you \*must\* honor the commitments to

the contract.

Otherwise, not only will we lose the Rays, but the Phillies and Blue Jays will think twice about signing spring training renewals, and it will send a flare to the business community at-large that Pinellas County is \*not\* business friendly because the County can renege at its leisure, legally binding commitments be damned.

I know you need to show your constituents you "tried to prevent businesses from strong-arming" the county for reelection purposes, but you have a fiduciary duty to approve what was agreed upon and signed. We all understand the rationale of the original delay after dealing with Helene and saw Milton impending, but even a delay of one more month sends the message that Pinellas is no longer a good business partner and can't be trusted.

On Tuesday, I highly encourage you vote to move the bonds forward and end this farce. Even if you think the Rays are getting an unfair deal (they're not, since they're paying for over 60% of the costs and a much increased tax burden from today, and that's a high percentage compared to other projects), your body had the chance to negotiate and did so. We are no longer at that point.

Will you be a business-friendly body that honors its commitments for decade to come, or will you allow Hillsborough, Orange, Duval, Miami-Dade, and practically every other large county in the state hold that over us forever, poaching our medium- and large-business tax base in perpetuity?

Dear County Commissioners,

I am a Pinellas County native (St Pete Beach), St Petersburg resident and business owner and active participant in civic life in our county (current or former Board member or Board President of the Bayfront Hospital, Temple Beth El, Habitat for Humanity of Pinellas County and Gulfcoast JFCS and Public Policy vice chair of the St. Pete. Chamber of Commerce). I am writing to urge you to approve the bonds next week for the new stadium for the Tampa Bay Rays, anchoring development of the larger Gas Plant District in downtown St Pete.

Our County has been battered during this storm season disrupting the lives of many of our neighbors (I too had damage to my home; fortunately not catastrophic). Restoration of our communities as soon as possible must be our top priority. This is a goal we can achieve together during the next 12 months. However, at the same time, we need to keep an eye on the future of our County in order to ensure long term economic development and support the future evolution of our tourist based economy. The prior County Commission voted to approve the heavily negotiated deal with the Rays earlier this year and it is important that our County stand by its commitments.

Having the TB Rays play in Pinellas County is a boon to our tourist industry and tourist tax collections during slow summer months. How many times have we all attended Rays games when half or more of the crowd is rooting for the other team? Many of these fans come to games from other parts of Florida or out of state. The national media attention of games at the Trop garners attention to our county and region and opens many eyes about the diverse economy and lifestyle we enjoy here in Pinellas County, and dispels notions that St Pete/Clearwater is simply a place to vacation or retire.

Most important, this project makes economic sense. The Rays Hines team plans to develop an ambitious mixed use project around the stadium adding potentially \$5.0 billion to our County's tax rolls over the next 20 year period. The County and our County schools receive a material amount of the property taxes generated in the city of St Petersburg and will be important beneficiaries of these new tax revenues. If the project doesn't proceed, the game plan for the 86 acre Trop site is uncertain and the County and School Board will delay or lose millions of dollars of tax revenues.

The tourist tax funds required to support the bonds cannot, as I understand, be used to fund the cost of other County needs, such as hurricane restoration and new and better infrastructure. They must be used for tourist promotion purposes or to fund other capital projects which support tourism. In my opinion, we don't need even more bus benches in Chicago, Boston and New York promoting a visit to St Pete/Clearwater (tourist tax revenues are more than enough to advertise and promote our area as a tourism destination and to help fund a new stadium for the Rays); we need to a

long term vision for bringing our tourist-based economy into the 21<sup>st</sup> century and support smart redevelopment of our fully built out county.

This project is essential for the future of our economy and approval of the bonds is the fiscally conservative option. I urge you to ratify the decision of the prior Commission by approving the bonds. Let's move forward.

I am a new St. Petersburg resident (I live at Ascent downtown) and I absolutely love the city and the county as a whole. I'm also a proud Republican and would have voted for you this year if you were up for reelection since we agree on most issues.

With that being said, this issue before us is one that will define our county for years and which we cannot afford to make a fatal mistake on. We need to keep moving forward with our growth and evolution as a county and the Gas Plant District redevelopment/new Rays stadium is an essential part of that.

It's my understanding that despite your technical 'no' vote on the final plan proposal you were overall supportive of the concept though you wanted some additional tweaks.

As a taxpayer and resident of the county I very much appreciate your due diligence on that. I really do. But that time has come and gone and it's time to do the right thing and not hold this up any further. It should just be a procedural matter (a 'yes' vote) since the details of the plan were already presented, debated and agreed upon.

A few additional things from me for you to consider (respectfully):

1) It is only going to be one season and then the Trop will likely reopen and things will be back to normal in terms of revenue for the city and county for 2026 and 2027 until the new stadium opens (assuming it does). I've done my research and understand the Lightning played three seasons at the then-Thunder Dome while Amalie Arena was under construction in Tampa. Hillsborough still 'let them go' and it all worked out in the end for both parties.

2) If the deal falls through the negative economic impact to Pinellas would be enormous given the projections I've read from the Gas Plant Distract development and the fact that I understand the Rays organization gets to keep all the revenue anyways even if a stadium isn't ultimately built! That would be very bad news for the county.

Additionally, both the recent Texas Rangers stadium in Arlington and the Atlanta Braves in Cobb County are now both profitable and in the Rangers case many who opposed the county's decision to build the stadium are now happy it was indeed built: [Rangers home Globe Life Field cost worth it, say Arlington taxpayers who helped foot bill](#).

3) This is such a growing region and you certainly know Hillsborough doesn't have the public money to support both the Rays and Bucs so Pinellas is the best option for the Rays.

There are only 30 MLB franchises and they are a tremendous source of pride (outside the revenue discussion) for cities/regions. If we end up losing the Rays, we will never get another team and you and others who would vote against the new stadium bond would forever be remembered as 'the group who lost the team.' I don't think you or the others want that, ultimately.

4) This bond vote from my understanding was mostly thought of as a formality after the deal was agreed to so what would it say to other businesses who want to do business with the county that the deal was pulled in the 11th hour (if you vote no)?



Good Evening,

There has been recent news and social media about certain Pinellas County commissioners that wish to scuttle the Historic Gas Plant and Rays Stadium funding by voting no to the bonds to fund these projects. It is distasteful and self-serving to use the recent natural disaster of Hurricane Milton as the excuse for this. It is further irrational to use the reason that the Rays are playing one season in Hillsborough County as if the Rays had any other choice. It is prudent for any rational person to understand that the Rays hand was forced and they have no other option for the 2025 season. To expect them to find a place in Pinellas County for 2025 and to hold the project hostage by using that for justification is downright sinister. Baycare Park in Clearwater and TD Park in Dunedin were not viable options for the Rays to play in this upcoming season for many reasons.

Traffic / Logistics - have you ever tried to drive to Dunedin during rush hour when weekday games occur? There are no major roadways. Let alone, Dunedin doesn't even have a parking lot. We attend many Dunedin Blue Jays games and Toronto Spring Training games. Parking and traffic are horrible even for those events that are way less attended. While getting to Baycare is a little better with US19 going by, the parking and traffic situation is still difficult and noticeably so during sold out events such as their 4<sup>th</sup> of July events. Steinbrenner field has easy access from Tampa airport, is convenient to Dale Mabry Hwy and I-4, as well as Hillsborough Avenue which are all major roadways. They have ample parking across the street at Raymond James stadium

Seating Capacity - Steinbrenner's capacity is around 11,000. Baycare is around 8500 (mind you 7500 seated and 1000 of that in the grass berm) and TD Ballpark is around 8500. That is a difference of 2,500 more seats at Steinbrenner per game. Multiply by 81 home games and that is 202,500 more fans to buy tickets and purchase concessions.

MLB Stadium Standards - Steinbrenner is the closest to being MLB ready in accordance with MLB and MLB Players Association standards. They have a renovated clubhouse, upgraded field lighting, expanded home locker room space, and improved training and rehabilitation capabilities.

For those few reasons above, it is simply unfathomable to expect them to stay in Pinellas for the 2025 season and to believe they should have otherwise, is illogical. This is for one temporary season, they did not ask for Tropicana Field to be destroyed and 2025 season would be played there if it weren't for that which is obviously outside of their control.

Now that we've debunked Councilmember Latvala's emotional reasons for wanting to vote NO as he apparently feels scorned by them playing at Steinbrenner and appears to want to vote with his feelings rather than his intellect, let's move on to the other reasons this project needs to be voted YES to approve the bonds to fund it.

- The Historic Gas Plant and Rays Stadium has already been through years of public processes and votes to approve it.

County Commissioners:

On Tuesday, you will be making a vote of historic significance to Pinellas County and St. Petersburg - the vote to approve or reject the sale of bonds to provide funds for a new baseball stadium.

I strongly urge you to vote No - do not authorize Pinellas County to issue bonds to build a stadium. I don't think it is too strong to say that the future of our economy, our homes, our beaches, our infrastructures, and our jobs depend on it. I know you agree we need to focus on what matters to make life better for all the citizens of Pinellas County. We are counting on you to not be blinded by a shiny object. - a pretty picture of a stadium. - but to do what is right.

My recommendation is based on:

1. The significant impact of two hurricanes on our beaches and our homes and our economy and as a result where we need to refocus our resources.
2. The more likely risk of future storms.
3. The uncertain sources of funds to repair the beaches now and to repair them when future storms are sure to come.
4. The risks to our tourism industry and the impact of that risk on more than 90,000 people's jobs - jobs that depend on tourism.
5. The undeniable facts that baseball does not drive economic growth and is not a significant source of tourism.
6. The Gas Plant site is ready for development and a stadium will not enhance that development. In some respects, the stadium will actually hurt development - traffic congestion, and a detraction from office and residential development. Thus, the property will generate the county's share of real estate taxes from its development more quickly without a stadium. (Why is it reported that Rays/Hines are still interested in

developing the property even without a stadium? They must also agree - contrary to what they said when they competed for the deal when they, the city and the chambers of commerce said that the stadium is an anchor for other development. The development of the rest of the property would be an anchor for a stadium.)

7. The development of the land that would have been set aside for a stadium, will now be developed for commercial purposes, generating additional Pinellas County property taxes.

In July, when the Pinellas County Commission voted to authorize the use of Tourist Development Tax revenue to fund the Rays baseball stadium in St. Petersburg, it seems that those who voted in favor based their decision on:

1. Current Tourist Development Tax (TDT) reserves were sufficient for the current needs to re-nourish the beaches and future TDT funds would be sufficient in the event of any emergencies - like a hurricane, should one ever hit our coast.

2. Spending \$312.5 million of TDT (\$600 including interest) on a stadium was consistent with the goals for the use of TDT. There were no higher priorities.

Fast forward to today, and those assumptions are being sorely tested. Who would have thought we could hit by not one but two hurricanes and the impact on our community. And now I hope you would agree, we are all worried that we can get hit by future storms.

Regarding the beaches, the beaches lost 30 years worth of beach re-nourishment from hurricanes Helene and Milton - and the cost of repairs - as much as \$130 million.

To make the repairs, not only does it appear that the county will need to dig into the emergency funds and more (no one could anticipate the damage TWO hurricanes would bring), there is no guarantee that either the federal government or the state will help pay the cost of repairs. And what about the \$130 million we will need after the next storm?

Immediately after the storms, there had been some hopeful signs from the Biden administration about funding. However, we've been in a holding pattern since November's election, and who knows if Trump will be as favorable to giving us support.

Can we afford to wait much longer? The longer we wait, the more the homes and infrastructure along the coast are exposed to further erosion.

### **Can the county still afford to fund a baseball stadium based on where things stand?**

Pinellas County has been gut punched by two storms in two weeks - something we never thought would happen. But now, with all of us worrying about when the next storm will hit our homes, trying to decide if we should rebuild or not, don't we have to worry about the next time our beaches will be torn about? And the impact on our homes? And the possibility that it might happen more often?

No matter the reason, the waters of the Gulf of Mexico are warmer and warmer water breeds hurricanes. Never before now have we ever seen a hurricane form in the western part of the Gulf and move directly east at us. But not that it has is happened everyone worries it can happen again.

With these real worries in mind, we need to have the funds for regular beach repairs. The beaches are the number one reason tourists come to Pinellas County, and tourism supports more than 90,000 jobs in the county, contributing over \$2.9 billion in wages. (The Visit St. Pete/Clearwater's own report shows that, when queried, 40% of visitors come to our area for the beaches, the pier, the restaurants and the museums. Only 4% said they visit here for sporting events.)

Regarding the economic and real state tax benefit of a stadium, more than 100 economic studies show that professional sports stadiums do not generate economic benefits. In the case of the Rays, they generate very limited tourism.

Owners of baseball teams want to locate their teams in areas with fast growth in the hopes it will increase attendance - not the other way around.

That the deal was not a done deal until both steps happened. In no way should you feel pressured by recent articles in the press.

We need to do what is right for the citizens of Pinellas County.

My name is Doug Battista. I am a resident of Palm Harbor in Pinellas County.

I am writing to share a personal story of my 8-year old son, who has a severe anxiety disorder called selective mutism. His condition causes him to panic and avoid other human beings, and as a result, he becomes a mute in front of other people. Up until a year ago, he would not attend gatherings with large groups of people and struggled in school - as he refused to speak or interact with other kids.

We moved to Florida 1.5 years ago, and I convinced my son to go to a Rays game. He was hesitant, and I wasn't sure that I would be able to get him to go through the entrance to the stadium. Dear County Commissioners

On Tuesday, you will be making a vote of historic significance to Pinellas County and St. Petersburg – the vote to approve or reject the sale of bonds to provide funds for a new baseball stadium.

I strongly urge you to vote No – do not authorize Pinellas County to issue bonds to build a stadium. I don't think it is too strong to say that the future of our economy, our homes, our beaches, our infrastructures, and our jobs depend on it. I know you agree we need to focus on what matters to make life better for all the citizens of Pinellas County. We are counting on you to not be blinded by a shiny object. – a pretty picture of a stadium – but to do what is right.

My recommendation is based on:

1. The significant impact of two hurricanes on our beaches and our homes and our economy and as a result where we need to refocus our resources.
2. The more likely risk of future storms.
3. The uncertain sources of funds to repair the beaches now and to repair them when future storms are sure to come.
4. The risks to our tourism industry and the impact of that risk on more than 90,000 people's jobs – jobs that depend on tourism.
5. The undeniable facts that baseball does not drive economic growth and is not a significant source of tourism.
6. The Gas Plant site is ready for development and a stadium will not enhance that development. In some respects, the stadium will actually hurt development – traffic congestion, and a detraction from office and residential development. Thus, the property will generate the county's share of real estate taxes from its

development more quickly without a stadium. (Why is it reported that Rays/Hines are still interested in developing the property even without a stadium? They must also agree – contrary to what they said when they competed for the deal when they, the city and the chambers of commerce said that the stadium is an anchor for other development. The development of the rest of the property would be an anchor for a stadium.)

7. The development of the land that would have been set aside for a stadium, will now be developed for commercial purposes, generating additional Pinellas County property taxes.

In July, when the Pinellas County Commission voted to authorize the use of Tourist Development Tax revenue to fund the Rays baseball stadium in St. Petersburg, it seems that those who voted in favor based their decision on:

1. Current Tourist Development Tax (TDT) reserves were sufficient for the current needs to re-nourish the beaches and future TDT funds would be sufficient in the event of any emergencies – like a hurricane, should one ever hit our coast.
2. Spending \$312.5 million of TDT (\$600 including interest) on a stadium was consistent with the goals for the use of TDT. There were no higher priorities.

Fast forward to today, and those assumptions are being sorely tested. Who would have thought we could hit by not one but two hurricanes and the impact on our community. And now I hope you would agree, we are all worried that we can get hit by future storms.

Regarding the beaches, the beaches lost 30 years worth of beach re-nourishment from hurricanes Helene and Milton – and the cost of repairs – as much as \$130 million.

To make the repairs, not only does it appear that the county will need to dig into the emergency funds and more (no one could anticipate the damage TWO hurricanes would bring), there is no guarantee that either the federal government or the state will help pay the cost of repairs. And what about the \$130 million we will need after the next storm?

Immediately after the storms, there had been some hopeful signs from the Biden administration about funding. However, we've been in a holding pattern since November's election, and who knows if Trump will be as favorable to giving us support.

Can we afford to wait much longer? The longer we wait, the more the homes and infrastructure along the coast are exposed to further erosion.

Can the county still afford to fund a baseball stadium based on where things stand?

Pinellas County has been gut punched by two storms in two weeks – something we never thought would happen. But now, with all of us worrying about when the next storm will hit our homes, trying to decide if we should rebuild or not, don't we have to worry about the next time our beaches will be torn about? And the impact on our homes? And the possibility that it might happen more often?

No matter the reason, the waters of the Gulf of Mexico are warmer and warmer water breeds hurricanes. Never before now have we ever seen a hurricane form in the western part of the Gulf and move directly east at us. But now that it has happened, everyone worries it can happen again.

With these real worries in mind, we need to have the funds for regular beach repairs. The beaches are the number one reason tourists come to Pinellas County, and tourism supports more than 90,000 jobs in the county, contributing over \$2.9 billion in wages. (The Visit St. Pete/Clearwater's own report shows that, when queried, 40% of visitors come to our area for the beaches, the pier, the restaurants and the museums. Only 4% said they visit here for sporting events.)

Regarding the economic and real state tax benefit of a stadium, more than 100 economic studies show that professional sports stadiums do not generate economic benefits. In the case of the Rays, they generate very limited tourism.

Owners of baseball teams want to locate their teams in areas with fast growth in the hopes it will increase attendance – not the other way around.

In conclusion:

1. Two hurricanes have changed everything.
2. We don't need a stadium to see the economic, tourist and real estate tax benefits from the development of the Gras Plant property.
3. Everyone knew then and they know now that the approval of the deal with Rays/Hines to build a stadium and for them to develop the rest of the property was a two step process of approval by the county and the city. That the deal was not a done deal until both steps happened. In no way should you feel pressured by recent articles in the press.

We need to do what is right for the citizens of Pinellas County.

Please bear with me through this email as I have never contacted an elected official before. However, with this vote coming up in the coming weeks involving the Rays new stadium bonds and the reality of how fragile the situation is, I felt it was necessary.

My name is Jacob Gullekson, a current Florida resident living for the moment in Spain. I was a Florida resident for the first time when the Rays threw their first pitch in 1998. I was only 5 years old at the time. I went to the second game they ever played at Tropicana Field and many before my dad received a new assignment at Offutt Airforce base in Omaha. Throughout my time in Omaha and later Italy, I remained a Rays fan and made sure to never miss a game whenever they were on.

In 2003, my dad received new orders, while we were in Italy, that we would be moving back to the Tampa Bay region, and I couldn't have been a happier boy at the time. From 2004 on, I went to at least 50 games a season and at least 30 once I moved away for college. The best birthday I ever had was when Evan Longoria hit 2 homeruns in their first ever playoff game in 2008. Even now, my dad has maintained my season ticket and goes to 40+ games a year. This past year, I went to 8 games for the time that I was home.

I have had some of the best memories of my life at Tropicana Field and have met almost all of those that I consider my best friends from going to Rays games. Almost all of those that will be my best men in my future wedding have all been friendships made through Rays baseball. I am even flying home this week to attend a funeral of one of those great friends I made at the Trop. It has also been the time I have best bonded with my father as well. I can't tell you how nice it is every time I come back home and get to sit back and catch a few games with him. It's just like being a kid again.

And if anyone knows about a team relocating, it's my father. He grew up a huge Milwaukee Braves fan just outside of Milwaukee and had to live through the team relocating to Atlanta. He still has trouble talking about how devastated he was when they decided to move. In fact, I have only been to Milwaukee once in my lifetime, because he still hasn't gotten over it over all this time, despite the fact that they were awarded the Brewers decades later.

In my life, I have lived through two baseball relocations, the Expos, and the Athletics. In both cases, there is a percentage of blame that could be put on the team itself as well as the council members in charge of the situations. I know that the Rays have blame in this issue too, and as a council member, it is your job to represent your city, but please remember that a professional team represents more than just a city, but a whole region. The Rays play a large part in the

professional sports market of all Central Florida, so when you make this decision in the coming weeks, please keep that in mind.

Please keep in mind as well that the level of play in the Florida State League has greatly diminished since Minor League Baseball realigned a few years back. Once all the minor league teams in Florida, short of Jacksonville and Pensacola became Low Single-A teams as opposed to what they previously were (High Single-A), the level and pace of play made it almost un-watchable to those that are even the best of baseball fans. Without the Rays, this is all we would have left other than the one month of Spring Training.

Once my future wife receives her US Passport and as a result becomes a Florida resident, I hope that we will have the Rays to enjoy for our lifetimes, our children's lifetimes, our grandchildren's lifetimes and so on. We plan on moving back to Central Florida sometime in the next few years and will have to make the decision between Orlando or the Tampa Bay region. Whether the Rays have a long-term future in the region will play a major part in that decision.

On one final note, I want to express how early in the process that Rays fandom really is. I am truly the first generation, at 31 years old, that has had the Rays around my whole life. I truly believe St. Petersburg can be a baseball town very similar to that of Seattle, Cleveland, or Kansas City. Those cities have multiple generations of fans now draw fans without many problems. Allowing the Rays to leave over a decision to play on the other side of the bay for one season will affect multiple generations of fandom that will never be able to be alleviated. I beg and pray that you don't make a shortsighted decision that could reap so many benefits for St. Petersburg and all Central Florida.

Hi Mr. Eggers,

I am writing to express concern over the potential "No" vote for the funding of the Rays stadium. While I understand all of your concerns for a better deal and potential neglect for other county matters, I humbly ask you to reconsider so we can keep an anchor of our community in Pinellas County.

I am a board member of Countryside Little League and first-hand witness to the impact the Rays make in our communities. In fact, the entire west coast of Florida Youth baseball is financially supported by the Rays through monetary donations, uniform donations, players volunteering, free tickets to games and more.

Over the last 2 years my next-door neighbor's son successfully battled Leukemia. One organization was there to support his journey from diagnosis to successfully ringing the bell to signal he was cancer free - The Tampa Bay Rays. Upon diagnosis he was able to throw the 1st pitch out at a Major League game and invited to multiple games after in suites to take his mind off of a life-threatening illness. At the end of his cancer journey, he was made honorary bat boy and celebrated pregame in an exclusive meet and greet with the Rays coaches and players.

As a member of this community, I've personally benefited from the Rays as a father taking enjoyment of my kids getting to witness the magic of comeback wins. I've benefited as a Little League coach taking my entire league to multiple games. I've benefited as a local entrepreneur taking prospects and clients to ball games and getting an opportunity to win their business.

I do understand the Rays playing a season in Hillsborough seems disrespectful, given the financial support committed to in July, however that decision is not on the Rays alone when you factor in the MLB Commissioner, MLB players union, and the financial devastation of missing out on multiple weekend games with 20,000+ in attendance.

I think we have to remember the majority of Pinellas wants the team to stay in St Pete long term. We are also excited about the investment into the community, where the new stadium is only about 1/5th of the total project investment. The additional development of about \$5.5B is dependent upon the new stadium being the anchor. In 10-12 years, a current vacant non-revenue producing portion of Pinellas County will have property tax values north of \$10B to generate tax revenue. An investment of \$315M by the county, financed over 30 years at about \$15-18M annually to bring in \$7.2B into Pinellas County is a deal we need to make.

I voted Yes for you when you decided to run for office because I believed you would help grow Pinellas county. I believed you would help grow jobs, support our youth, and see the bigger picture for Pinellas. I believed that you'd also understand that only 26 cities in America get to claim an MLB franchise and at any time another

city can take what should belong to Pinellas residents (many cities are ready to sign a deal). The longer we delay, the more expensive it gets ([could've had a new stadium for \\$450M in 2008](#)) and the higher the chance we lose the franchise altogether.

Please don't crash the hope of the majority of Pinellas County residents. I was very pleased when the latest stadium effort cleared each hurdle. I was shocked and dismayed to see Tropicana Field's roof get shredded during Hurricane Milton. I know there is frustration about the Rays playing in Tampa in 2025. It will certainly be a

longer drive for us for the beach if we are able to take in a game in 2025, but the important thing is that they will be in the region where they belong.

Now I am growing increasingly concerned about the reports of funding delays potentially killing the new stadium and Gas Plant District redevelopment, which brings me to the point of my message. I firmly believe that this is the best effort yet to keep the Rays in St. Petersburg where they belong, and it is probably the last chance to do so. Because of this, I strongly urge the Commission to not delay funding for the stadium.

The beaches will still be beautiful and popular, and can be restored over time, whether naturally or through human means. The clock on the Rays time in Tampa probably can't be reset after this. The Pinellas beaches will always be the best, but there's time to restore them. The Rays' time is now. Please, Commissioners, save the Tampa Bay Rays once and for all!

My name is Alex Reba and I am a constituent of yours in Pinellas County. I have been closely following the ongoing conversation regarding the Historic Gas Plant District Redevelopment.
