



NOTICE OF PUBLIC HEARING

Notice is hereby given that the Housing Finance Authority of Pinellas County, Florida (the "Authority") will hold and conduct a public hearing to be held on July 17, 2017 beginning at 8:30 a.m. or as soon thereafter as such matters may be heard, at the Pinellas County Board Records office, 315 Court Street, 5th Floor, Board Records conference room, Clearwater, Florida 33755, for the purpose of receiving comments and hearing discussion concerning a plan of financing (within the meaning of Section 147(f) of the Internal Revenue Code of 1986, as amended), on the following:

The proposed issuance by the Authority of its Multifamily Housing Revenue Bonds (Oceanside Estates), Series 2017, in an aggregate principal amount of not to exceed \$12,000,000 in one or more installments or series, the proceeds of which will be used to finance the acquisition and rehabilitation of Oceanside Estates, currently operated as a Senior Section 8 housing facility, consisting of 104 one-bedroom multifamily rental housing facility located in two three-story buildings to be rented to persons or families of moderate, middle or lesser income within the City of Pinellas Park, Pinellas County, and located on approximately 4.10 acres of land located at 6700 102nd Avenue North, Pinellas Park, Florida 33782. Oceanside Estates will initially be owned and operated by Oceanside Housing Partners LP, a Florida limited partnership, or one of its affiliates. All interested parties are invited to present their comments at the time and place set forth above.

Persons are advised that, if they decide to appeal any decision made at this hearing, they will need a record of the proceedings, and, for such purpose, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
