THIRD AMENDMENT

This Amendment is made and entered into this 20th day of May , 2025, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and VSC Fire & Security, Inc. hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on June 13, 2023, referred to as Pinellas County Contract No. 23-0476-ITB (hereinafter "Agreement"), pursuant to which the Contractor agreed to provide Fire Protection System Services for the County; and

WHEREAS, Section 25 ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for an increase to the contract value, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- 1. Section 6 ("Compensation and Method of Payment"), subsection B ("Spending Cap and Payment Structure") is revised to reflect an increase in the amount of Two Million, Three Hundred Seventy-Seven Thousand, Seven Hundred Fifty-Three Dollars and Zero Cents (\$2,377,753.00), for a new total not-to-exceed sum of Four Million, Three Hundred Seventy Thousand, Three Hundred Sixty-Eight Dollars and Zero Cents (\$4,370,368.00).
- Except as changed or modified herein, all provisions and conditions of the original
 Agreement and any amendments thereto shall remain in full force and effect.
