

# **NOTICE OF PUBLIC HEARING**

## **RESOLUTION SUPPLEMENTING THE PINELLAS COUNTY**

### **FY26 BUDGET**

The Pinellas County Board of County Commissioners proposes to adopt the following amendments to the FY26 Budget as required by Section 129.06 (2), Florida Statutes, relating to the realignment of reserves and appropriation of unanticipated revenue as specified herein.

A public hearing on the Resolution will be held on **Tuesday, February 3, 2026, at 9:30 AM** or as soon thereafter as may be accommodated by the completion of the rest of the Board agenda, in the Palm Room, 333 Chestnut Street, Clearwater, Florida 33756. Members of the public wishing to address the body are encouraged to attend in person, but may also attend virtually utilizing Communications Media Technology (CMT) on the Zoom platform or provide comments in advance.

To address the County Commission in person, members of the public are encouraged to preregister at <https://comment.pinellas.gov>. Preregistration is encouraged but not required if individuals plan to attend the meeting at the Palm Room in person. Those who have not preregistered may register in person when they arrive.

**Members of the public wishing to address the body virtually via Zoom or by phone are required to preregister by 5:00 P.M. the day before the meeting** by visiting <https://comment.pinellas.gov>. The registration form requires full name, address and telephone number if joining by phone, along with the topic or agenda item to be addressed. Members of the public who cannot access the registration form via the internet may call (727) 464-3000 to request assistance preregistering. Only members of the public who have preregistered by 5:00 P.M. the day before the meeting will be recognized and unmuted to offer comments. If a member of the public does not log in with the same Zoom name or phone number provided in the registration form, they may not be recognized to speak. In person appearances for comment, or advance comments as noted below, are preferred. The County will use its best efforts to facilitate virtual comment, but citizens using technology to comment virtually are cautioned that this mechanism is being offered by the County as a courtesy and the County does not guarantee the proper functioning of technology involved.

## **A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA; SUPPLEMENTING THE FY26 BUDGET**

The Resolution supplements the Fiscal Year 2026 (FY26) Adopted Budget by recognizing unanticipated revenue and realigning appropriations for requesting departments and funds, including:

- Recognize \$1,613,860 in unanticipated revenue and appropriate to operating expenses and grants and aids in the General Fund.
- Realign \$2,377,140 from reserves – contingencies and appropriate to operating expenses, capital outlay, and transfers to in the General Fund.
- Realign \$907,510 in operating expenses and appropriate to grants and aids in the General Fund.
- Recognize \$122,490 in unanticipated revenue and appropriate to capital outlay in the Emergency Medical Services Fund.
- Realign \$677,000 from reserves - future years and appropriate to capital outlay in the STAR Center Fund.
- Recognize \$1,918,400 in unanticipated revenue and appropriate to operating expenses, capital outlay, and reserves in the Emergency Communications E911 System Fund.
- Realign \$270,000 from reserves – contingencies and appropriate to operating expenses in the Building and Development Review Services Fund.
- Recognize \$40,000 in unanticipated revenue and appropriate to reserves in the CDBG-Disaster Recovery 2025 Fund.
- Recognize \$289,000 in unanticipated revenue and appropriate to reserves in the Construction Licensing Board Fund.
- Realign \$36,000 from reserve – contingencies and appropriate to operating expenses in the Solid Waste Revenue and Operating Fund.
- Recognize \$285,570 in unanticipated revenue and appropriate to operating expenses in the Water Revenue and Operating Fund.
- Recognize \$306,430 in unanticipated revenue and appropriate to operating expenses in the Sewer Revenue and Operating Fund.
- Recognize \$796,720 in unanticipated revenue and appropriate to operating expenses in the Sewer Renewal and Replacement Fund.
- Realign \$2,800,000 from reserves – future years and appropriate to capital outlay in the Sewer Renewal and Replacement Fund.
- Realign \$49,000 from reserves – contingencies and appropriate to operating expenses in the Risk Financing Fund.

Unanticipated revenue recognition in the proposed Resolution will cause an increase to the following fund totals below, realignments within a fund will cause a net change of \$0 to the fund.
