

NO WAY OUT - NOWHERE TO GO

9/8/25

When elected officials and public servants fail to keep the safety of residents front of mind, one can end up facing unnecessary risk, like the 2-year span of life-threatening risk the tens of thousands of residents of the combined Ridgemoor and Tarpon Woods communities will face, starting in June of 2026.

In January of 2024, Pinellas County Public Works (PCPW) and the Florida Department of Transportation (FDOT) held their first public meeting at East Lake High School, informing Ridgemoor and Tarpon Woods residents that a plan was being finalized to replace the Brooker Creek Bridge along Ridgemoor Blvd. During the prior years of developing that plan, neither PCPW nor FDOT bothered to engage with residents about what could have been “options”. Although permits could have been obtained to build a replacement bridge to the north or south of the existing bridge, that was not done.

Another example of late thinking by PCPW and FDOT on this project was evidenced by the first communication had by them with the Fire Chief of the East Lake Fire Department, the leader of critical first responders to medical and fire emergencies. That first communication occurred only one month before the initial public meeting in January of 2024. In December of 2023, a representative of PCPW told Fire Chief Jason Gennero that it was the plan of PCPW and FDOT to totally demolish the bridge and, over a 1-year period, build a replacement bridge in the same footprint of the old bridge. This meant that the PCPW and FDOT plan would require all traffic in and out of the combined Tarpon Woods and Ridgemoor communities to traverse the congested two lanes of Tarpon Woods Blvd. Upon hearing of this plan, Chief Gennero explained that shutting down Ridgemoor Blvd would create a life-threatening situation for residents in the area because it would extend emergency response time by as much as 7 minutes, which was unacceptable. He explained that, if Ridgemoor Blvd was closed to traffic, his department would need to establish a satellite fire station within Ridgemoor to ensure prompt emergency response.

Upon receiving this last-minute information from Chief Gennero, PCPW and FDOT decided to alter their plan to totally demolish the Brooker Creek Bridge along Ridgemoor Blvd, and revised it to a plan that would demolish one-half of the bridge at a time, so traffic could be regulated in both directions over one lane during a 2-year period. If you are not familiar with the risks of partial bridge demolition procedures, the repeated flooding of Tarpon Woods Blvd., or the extensive community development in the area being assessed by the County, that sounds like a logical option. The only problem with that “logical” option is, it gambles with the lives of residents in the area.

According to PCPW and FDOT personnel, this bridge is being replaced because it is deteriorating. The creek that flows under the bridge has washed away much of the creek bed that surrounds the

bridge pilings. When heavy rains occur, the creek swells and the waterflow increases significantly. So, what will happen when the bridge is cut in half, the half of it that remains carries twice the traffic it would have otherwise, and we go through 2 full hurricane seasons that could create very heavy waterflow under the bridge. Also, it is not out of the question that the process that will be used to cut the bridge in half might undermine the stability of the undemolished half, and could result in the full closure of Ridgemoor Blvd.

The PWPC manager for this project advised that, the bridge replacement plan could be impacted or changed, depending on how things develop as the contractor cuts the bridge in half. That comment raised red flags, so we tried to get clarification from FDOT on that issue. FDOT has confirmed that they have no expectation of getting a guarantee from the contractor that the contractor's partial demolition of the bridge will not render it unable to handle any traffic. According to FDOT, the demolition process is not expected to render the bridge unable to carry traffic, but that isn't guaranteed. The fact is, unexpected contractor errors on bridge and road projects have destabilized roadways.

Now, let's add the other issues that ignore risk to the impacted residents. If the partial bridge demolition causes Ridgemoor Blvd. to be closed, the only other route out of the surrounding area for tens of thousands of residents is Tarpon Woods Blvd., a two-lane road that always floods during heavy rains as evidenced by the photos below taken of Tarpon Woods Blvd. after our last 2024 hurricane:



PWPC and FDOT does plan to widen a small portion of the Tarpon Woods Blvd. and East Lake Road intersection in an attempt to improve the flow of traffic from Tarpon Woods Blvd to East Lake Road, but the reality is that minimal widening of the intersection will do very little to alleviate the traffic congestion that will build along the two-lanes of Tarpon Woods Blvd that runs from Ridgemoor Blvd. to East Lake Road.

Logically thinking this scenario out further, during two hurricane seasons, there is no doubt that this area will be impacted by tropical depressions and hurricanes. That will flood Tarpon Woods Blvd. and, if the partial demolition of the Brooker Creek Bridge on Ridgemoor Blvd causes it to become unstable, residents will be prevented from evacuating. Even worse, emergency vehicles will not be able to access the impacted communities.

An additional factor brought into play by the County also ignores risk to residents. Plans are underway by an entity that purchased Tarpon Woods Golf Course to either attempt to build housing on some of that land, or to convert the land that previously served as the Tarpon Woods Golf Course into a Wetlands Mitigation Bank. Either project will require the new owner of the property to remove any contaminated soil throughout the footprint of the Tarpon Woods Golf Course. Experienced civil engineers advise that the top 2 feet or more of the entire golf course property will undoubtedly be deemed hazardous material because it has been saturated with pesticides over the past 4 decades. That contaminated soil will have to be loaded into dump trucks and removed. Why isn't the transformation of the Tarpon Woods Golf Course into whatever it will become prohibited while the bridge replacement project is underway. Untold numbers of dirt filled dump truck traffic will significantly add to congestion along Tarpon Woods Blvd. and the half-demolished Brooker Creek Bridge, assuming it is not damaged from the demolition process. It also seems logical that this added traffic of dirt filled dump trucks, if they travel along Ridgemoor Blvd., may further compromise the half-demolished bridge.

PWPC and FDOT should take the factors outlined above into consideration and change their plan for this bridge replacement project. If they refuse, at a minimum they need to dramatically shorten the time the contractor is given to complete the project. Why can't the contractor be required to perform work during extended work days (12 hours or more per day) and on weekends. Bridge contractors were able to replace large sections of the Sanibel Island bridge in 15 days after it was destroyed by the 160 mile per hour winds of hurricane Ian in 2022. The work needed to be performed to replace the little Brooker Creek Bridge on Ridgemoor Blvd. is minimal in comparison.

One might suggest these life-threatening circumstances may not occur, but why are public servants and elected officials taking that chance with tens of thousands of lives? It is not too late to confront the fact that the current plan is not the best plan, and it is potentially life-threatening.

Please share these details with your neighbors, with the officers of your HOA, and with elected officials. **Along with other issues, this bridge replacement project will be addressed during a meeting of the Council of North County Neighborhoods (CNCN) on September 15, 2025, at 7:00pm. The meeting will be held at the East Lake Library, 4125 E Lake Road. Both Senator Ed Hooper and State Representative Adam Anderson will be in attendance. PLEASE ATTEND THIS MEETING AND SHARE YOUR VIEWS ABOUT THE BRIDGE REPLACEMENT PROJECT.**

RIDGEMOOR BOULEVARD BROOKER CREEK BRIDGE REPLACEMENT PLAN

STATEMENT TO COUNTY COMMISSIONERS ON 10/21/25

My name is Randy Burr, I am before you today, not as an elected fire commissioner of the East Lake Tarpon Special Fire Control District, but as a resident of Ridgemoor, along with many residents of our Ridgemoor and Tarpon Woods communities. I am one of thousands of homeowners that are opposed to certain aspects of the current Florida Department of Transportation (FDOT) and Pinellas County Public Works (PCPW) plan to replace the Brooker Creek Bridge along Ridgemoor Boulevard in Palm Harbor. We believe the current replacement plan for that bridge fails to sufficiently mitigate public safety and potential life-threatening circumstances.

Although we have raised these concerns over the past 2 years on many occasions, it does not appear any measures have been taken to mitigate the public safety risk we fear. We previously voiced our concerns at two public meetings held by representatives of the County and FDOT. Thanks to Commissioner Eggers, we met with County representatives at his office, and we submitted detailed papers about our concerns, like a paper entitled "NO WAY OUT - NO WHERE TO GO" that we shared with each County Commissioner in advance of this meeting. I have brought another copy of that paper today, to have it become part of the official record of today's Commissioners Meeting.

We would like your help to enhance scrutiny of the current plan for the replacement of this small 170-foot two-lane bridge. We believe the current plan will not only create an unmanageable bottleneck of traffic for 2 years, but it will also create potential risks that endanger our families.

The current plan calls for a contractor to demolish one of the two current lanes of the bridge, use the one remaining lane to allow traffic to flow in both directions, and to have the only other road servicing our communities be Tarpon Woods Boulevard.

The project was last said by FDOT and PCPW to commence during the hurricane season of 2026, so it will be under construction during at least 2 hurricane seasons.

It is not out of the question that demolishing one lane of the existing bridge could undermine the stability of the entire structure and could lead to a full closure of Ridgemoor Boulevard. That would create catastrophic risk for us.

The PCPW manager for this project advised that, "the bridge replacement plan could be impacted or changed, depending on how things develop as the contractor cuts the bridge in half." The FDOT Project Manager for this project confirmed that such an event could occur, but despite that, they have no expectation of getting a guarantee from the contractor that the bridge will remain open during construction. I'm providing the Clerk a copy of email communications by FDOT Project Manager Mark Dunn with one of our residents on this issue, and I have brought copies of these emails for each Commissioner. You will see highlighted in yellow that Mr. Dunn noted, "There is no such written guarantee provided by the contractor. No one can predict with complete certainty

whether partial demolition of the bridge will require a total shutdown of the proposed single lane during construction.”

At the least, we believe any bridge replacement contract to partially demolish and replace the bridge should require the contractor to incur significant financial penalties and agree to specific terms they must follow to continually keep the partially demolished bridge in a condition that will safely handle the traffic that flows over that bridge every day. That traffic includes school buses full of children, fire trucks, dump trucks, garbage trucks, and other heavy equipment.

If the partial bridge demolition causes Ridgemoor Blvd. to be closed, the only other route in and out of the surrounding area for thousands of residents is Tarpon Woods Blvd., a two-lane road that always floods during heavy rains. Most often, the flooding in Tarpon Woods occurs because the banks of Brooker Creek crest. All the water pumping in the world will not mitigate that flooding because pumps would simply pump additional water into the creek that is already overflowing into our communities. Please go to the website, savetarponwoods.com. At that site, you will find a link to drone footage that documents the heavy flooding throughout Tarpon Woods during and after Hurricane Milton. Traffic could not move along Tarpon Woods Blvd. for several days.

If the remaining half of the bridge were to become unable to handle traffic, and we were faced with another hurricane or even a strong tropical storm, thousands of residents would potentially be stranded, with no access available by emergency responders or sheriff’s office personnel for an extended period of time.

Even without a hurricane, East Lake Fire Chief Jason Gennaro noted that the total closure of the bridge would add an additional 7 minutes of response times to Ridgemoor communities, creating life threatening delays. Chief Gennaro stated that an extended closure of Ridgemoor Boulevard would require establishing a satellite fire station within our communities east of the bridge to ensure safety. The cost of personnel, equipment and facilities for that satellite station would be excessive.

The current bridge needs replacement because, during heavy rains, the flow of water within Brooker Creek continues to wash away dirt from around it’s concrete supports. Even if the proposed partial demolition of the existing bridge is initially successful, the remaining lane will handle twice the volume of traffic it currently handles. Add in any significant weather events, and the chances of the undemolished lane becoming unstable during the replacement project is certainly a possibility.

In addition, we have serious concerns about traffic flow along the proposed single lane. The current plan calls for a temporary light and gate on both ends of the single lane of traffic. When asked, PCPW and FDOT said these temporary lights will be gasoline powered, unmanned, and unmonitored. There is no guarantee that the one lane of traffic, managed by two gas operated gates, will always function properly with no breakdowns, vandalism, or other malfunctions, and that the single temporary lane will not be obstructed because of significantly congested traffic volume.

We request that, during the first 30 days of the project, county personnel be on site for the express purpose of monitoring the temporary lights and gates, especially during morning and evening rush hour traffic, to ensure that they are functioning efficiently, are being obeyed and not causing significant backup. Cameras should also be stationed on both sides of the bridge to enable remote monitoring of the traffic flow and a method of determining when personnel need to come to the site to correct problems with the lights or gates.

The current plan for the replacement of this bridge does not consider any Accelerated Bridge Construction (ABC) techniques, nor does it consider extended workdays and weekends to shorten the proposed two-year period of construction. Accelerated Bridge Construction uses innovative planning, design, and prefabricated materials, in a safe and cost-effective manner to reduce the onsite construction time that occurs when building new bridges or replacing existing bridges. Why hasn't the replacement of this tiny 170-foot bridge been evaluated using this available technology?

For comparison purposes, the world's tallest bridge, a suspension Bridge in Southern China, was just opened this year. It stands 2,050 feet above a river and is 4,600 feet in length. It has parallel parking spaces along both sides of the bridge, and has an express elevator that takes tourists to an observation deck that boasts a retail coffee shop. It offers bungee jumping from a glass walkway 1900 feet above the river. That bridge was completed in 3 ½ years.

In response to our efforts to get PCPW and FDOT to delay this bridge replacement project and consider all our concerns, senior PCPW and FDOT personnel stated that any delays could jeopardize their access to \$3.7 million in federal funds available for this project. Our question is, can County and State officials work with federal agencies to secure a clearly defined extension of time during which these funds can remain available for this project. With that guarantee in place, safer and more reasonable construction alternatives can be evaluated.

We are grateful that Commissioner Eggers has made himself available to us, heard us on these issues, and expressed an interest to do what he can to address our concerns, but the current bridge plan that does not address our concerns will commence in less than 1 year. We came before the board today because we think these issues create risk, not only for our communities, but the County in general, in terms of future project funding and overall community safety. We respect your service to the residents of the county and hope you will facilitate some innovative changes to this bridge replacement plan to mitigate our risk.

I am submitting a transcript of our statement to the Clerk, along with ____ signed endorsements of that statement received from many of our neighbors. I ask that the transcript and signed endorsements be made a part of the record. I am also submitting 8 additional copies of the transcript of our statement, 1 for each of the Commissioners, and one for Administrator Burton.

Hi Mr. Panzanaro,

Thank you for your email. I hope you enjoyed your Labor Day weekend.

There is no such written guarantee provided by the contractor. No one can predict with complete certainty whether partial demolition of the bridge will require a total shutdown of the proposed single lane during construction. The Engineer of Record and design team have performed engineering calculations of the stability of the bridge in it's existing condition, as well as in subsequent conditions during construction, including when a portion of the bridge deck is removed. Engineers have a professional and ethical obligation to perform due diligence in their calculations to ensure public safety. This process is carried out through design to confirm stability of the bridge to the greatest extent possible and ensure safety is not compromised. When the contract is awarded, the contractor will follow the plans, including technical specifications for the construction approach. As previously noted, these specifications (specifically FDOT Standard Specifications 110-6.3) require the contractor to submit a demolition plan for review and approval by the Engineer (CEI). The contractor may not proceed with partial removal of the existing bridge without this approval.

As Ms. Hammer Levy has previously noted, this is the same approach that is taken for all bridge reconstruction projects that require partial demolition of the bridge in order to maintain traffic across the bridge.
