AMENDMENT NO. 1 TO THE COOPERATIVE AGREEMENT BETWEEN PINELLAS COUNTY AND THE CITY OF TARPON SPRINGS FOR THE DEVELOPMENT THE COMPREHENSIVE WATERSHED MANAGEMENT PLAN FOR ANCLOTE RIVER

THIS FIRST AMENDMENT (this "FIRST AMENDMENT") TO THE COOPERATIVE AGREEMENT BETWEEN PINELLAS COUNTY AND THE CITY OF TARPON SPRINGS FOR THE DEVELOPMENT OF THE COMPREHENSIVE WATERSHED MANAGEMENT PLAN FOR ANCLOTE RIVER (the "ORIGINAL AGREEMENT") is made and entered into this __14_ day of __May _____ 2019, by and between PINELLAS COUNTY ("COUNTY"), a political subdivision of the State of Florida, and the CITY OF TARPON SPRINGS ("TARPON SPRINGS"), a municipal corporation, (the COUNTY and TARPON SPRINGS are collectively referred to herein as "PARTNERS").

WITNESSETH:

WHEREAS, PARTNERS entered into the ORIGINAL AGREEMENT on March 31, 2017, for the purpose of developing a Comprehensive Watershed Management Plan for the Anclote River (the "WMP");

WHEREAS, the ORIGINAL AGREEMENT expired on March 31, 2019;

WHEREAS, PARTNERS wish to extend the ORIGINAL AGREEMENT until December 31, 2020 to provide for completion of the WMP;

WHEREAS, Section Ten (10) of the ORIGINAL AGREEMENT provides for term extensions to the ORIGINAL AGREEMENT through written mutual agreement of PARTNERS;

NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained herein, PARTNERS hereby mutually agree as follows:

- 1. ORIGINAL AGREEMENT, Section Ten (10), "AGREEMENT TERM," is hereby amended in its entirety as follows:
 - This AGREEMENT shall take effect upon execution by both parties and shall remain in effect until December 31, 2020, unless renewed or extended by mutual written agreement of PARTNERS.
- 2. This FIRST AMENDMENT shall become effective upon execution by both PARTNERS.
- 3. Except as changed or modified in this FIRST AMENDMENT, all provisions and conditions of the ORIGINAL AGREEMENT shall remain in full force and effect.
