

RESOLUTION NO. 23- 5

A RESOLUTION APPROVING THE ISSUANCE BY THE HOUSING FINANCE AUTHORITY OF PINELLAS COUNTY OF ITS MULTIFAMILY HOUSING REVENUE BONDS (RIVERSIDE APARTMENTS), SERIES 2022 IN THE AGGREGATE AMOUNT NOT TO EXCEED \$39,000,000 TO PROVIDE FUNDS TO FINANCE THE MULTIFAMILY RESIDENTIAL RENTAL HOUSING PROJECT FOR THE BENEFIT OF OK RIVERSIDE LLC, A FLORIDA LIMITED LIABILITY COMPANY, OR ITS AFFILIATE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Housing Finance Authority of Pinellas County, Florida (the "Authority") has authorized the initiation of official action to issue its Multifamily Housing Revenue Bonds (Riverside Apartments), Series 2022 (the "Bonds") on behalf of OK Riverside LLC, a Florida limited liability company, to provide financing for the acquisition and rehabilitation of a residential rental facility known as Riverside Apartments, which consist of approximately 304 units and is located at 1589 Starlight Cove, Tarpon Springs, Florida; and

WHEREAS, the Authority conducted a public hearing on December 6, 2022, notice of which hearing was published on November 17, 2022, the Authority's website at [www.pinellascounty.org/hfa](http://www.pinellascounty.org/hfa) (a copy of which notice is attached hereto as Exhibit "A" and incorporated herein), for the purpose of considering the issuance of the Bonds by the Authority in the aggregate principal amount not to exceed \$39,000,000, in conformance with the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended. Said public hearing disclosed no reason why the Bonds should not be issued.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA (THE "BOARD"):

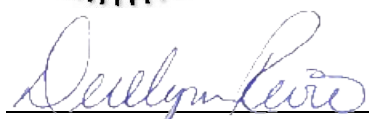
Section 1. The Board, pursuant to and in accordance with the requirements set forth in Section 147(f) of the Internal Revenue Code of 1986, as amended, hereby approves the issuance by the Authority of its not to exceed \$39,000,000 Multifamily Housing Revenue Bonds (Riverside Apartments), Series 2022 (with such designation to reflect the year in which the Bonds are issued).

Section 2. Nothing contained in this consent and approval shall be deemed to create any obligation or obligations of Pinellas County or the Board of County Commissioners.

Section 3. This resolution shall take effect immediately upon its adoption.

## NOTICE OF PUBLIC HEARING

Notice is hereby given that the Housing Finance Authority of Pinellas County, Florida (the "Authority") will hold and conduct a public hearing to be held on December 6, 2022 beginning at 8:30 a.m. or as soon thereafter as such matters may be heard, at the offices of the Authority located at 450 Carillon Parkway, Suite 105, St. Petersburg, Florida 33716, for the purpose of receiving comments and hearing discussion concerning a plan of financing (within the meaning of Section 147(f) of the Internal Revenue Code of 1986, as amended), on the following:

The proposed issuance by the Authority of its Multifamily Housing Revenue Bonds (Riverside Apartments), Series 2022, in an aggregate principal amount of not to exceed \$39,000,000 in one or more installments or series, the proceeds of which will be used to finance the acquisition and rehabilitation of a 304 unit multifamily rental housing facility for persons or families of moderate, middle or lesser income within the City of Tarpon Springs, Pinellas County, which is located at 1589 Starlight Cove, Tarpon Springs, Florida, which will initially be owned and operated by OK Riverside LLC, a Florida limited liability company, or its affiliate.

All interested parties are invited to present their comments at the time and place set forth above.

Persons are advised that, if they decide to appeal any decision made at this hearing, they will need a record of the proceedings, and, for such purpose, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
