Summary:

This lawsuit arises as a result of a motor vehicle/motorcycle accident, which occurred on April 24, 2014, at a red light on the southbound exit ramp at the intersection of US 19 and East Bay Drive. Plaintiff alleges that he was stopped at the red light behind two stopped vehicles when a Pinellas County water truck, operated by a Pinellas County employee, acting within the course and scope of her duties, traveling southbound on the exit ramp and approaching the red light and a stopped line of vehicles, failed to stop and collided with the rear of Plaintiff's motorcycle. Plaintiff alleges that the collision with the Pinellas County water truck caused personal injuries and property damages.

Plaintiff suffered herniations in his cervical and lumbar spine. After a conservative course of medical treatment, Plaintiff underwent a series of epidural spinal injections that failed to alleviate his pain. He then underwent two decompression surgical procedures, one to his cervical spine and one to his lumbar spine. His physicians have opined that should his cervical and lumbar pain continue unabated, additional surgical procedures, to include one or more spinal fusion procedures, would be recommended. Medical bills total approximately \$120,000.00. Property damages have not been quantified. Wage losses of \$170.00 per week for the

period of time that the Plaintiff was unable to work as a result of his injuries and resulting medical care were also claimed. For the purposes of facilitating the mediation conference, the parties agreed not to consider property damages or lost wages. Such losses were not waived for the purposes of trial but only to facilitate the quantification of damages for the purpose of the mediation conference.

As part and parcel to this negotiated settlement, Plaintiff will execute a release of all claims against Pinellas County and voluntarily dismiss the above-referenced lawsuit with prejudice.

Risk, County Administration and County Attorney staff met and reached the conclusion to recommend that the Board of County Commissioners accept this mediated settlement in the amount of \$100,000.00.
