Under his leadership, the company installed over 500 megawatts of wind power in the United States within the first 3 years of operation growing from inception to over \$600M in revenues during this period. Earlier in his career, Adrian held senior operations positions with Knowles Electronics, Gulfstream Aerospace and USRobotics. Adrian earned his MBA from the Kellogg School of Management at Northwestern University and received his Bachelor's degree in Chemistry from The Citadel. He serves as an Executive Partner for Salt Creek Capital and sits on the advisory boards of The University of Iowa's College of Engineering and The Citadel's College of Math and Science. In addition, he is a member of the board of directors for the Florida Medical Manufacturers Consortium. He is a US Air Force veteran having served as a Communications-Electronics Officer with assignments in the United States and Asia.
