

**FIRST AMENDMENT TO
SPECIFIC PERFORMANCE AGREEMENT
WITH STARTING RIGHT, NOW, INC. (CD17SRN)**

THIS AMENDMENT (AMENDMENT) is made and entered into this 23 day of April, 2019, by and between **Pinellas County (COUNTY)**, a political subdivision of the State of Florida, having its principal office at 315 Court Street, Clearwater, Florida 33756, and **Starting Right Now, Inc., (AGENCY)**, a not-for-profit organization, organized under the laws of the State of Florida, including its successors, assigns, and transferees, having its principal office at 5328 Primrose Lake Circle, Suite A, Tampa, Florida 33647:

WITNESSETH:

WHEREAS, **COUNTY** entered into Specific Performance Agreement **CD17SRN** (AGREEMENT) with **AGENCY** to provide, through the Pinellas County Planning Department (DEPARTMENT), **\$163,000.00 (One Hundred, Sixty-Three Thousand and NO/100 Dollars)** in Community Development Block Grant (CDBG) funds to **AGENCY** for facility renovations at 4600 Haines Road North, St. Petersburg, Florida 33714; and

WHEREAS, the 2017-2018 Action Plan, approved by the Board in Resolution 17-37, identified funding be provided to **AGENCY** for facility improvements to include the demolition and reconstruction of a covered walkway and installation of a sport court, hangout deck, community garden, landscaping and necessary site work; at 4600 Haines Road North, St. Petersburg, Florida 33714 (the PROJECT); and

WHEREAS, the **AGENCY'S** commencement of the PROJECT was postponed due to insurance requirement compliance delays; and

WHEREAS, the AGREEMENT states the PROJECT activities shall be completed by the AGREEMENT expiration date of June 30, 2019; and

WHEREAS, the **AGENCY** will not be able to complete the PROJECT before the AGREEMENT expiration date; and

WHEREAS, the **AGENCY** has requested and the **COUNTY** has agreed to extend the AGREEMENT expiration date to **September 30, 2019**.

NOW, THEREFORE, in consideration of the mutual covenants, agreements, understandings, undertakings, representations and promises, and intending to be legally bound thereby, the parties do hereby covenant and agree that the recitals set forth above are true and accurate and are hereby incorporated in and made a part of this AMENDMENT, and further covenant and agree as follows:

1. That Section 3. TERM OF AGREEMENT; EFFECTIVE DATE, shall be deleted and replaced with the following:

3. TERM OF AGREEMENT; EFFECTIVE DATE

This AGREEMENT shall become valid and binding upon proper execution by the parties hereto. This AGREEMENT is effective on **October 1, 2017**, and unless terminated pursuant to the terms herein, shall continue in full force and effect until **September 30, 2019**, or until **COUNTY’S** full and complete disbursement of funding to **AGENCY**, whichever comes first. **AGENCY** may use the funds provided herein to cover eligible PROJECT expenses incurred by the **AGENCY** between **October 1, 2017** and **September 30, 2019**.

- 2. That Section 6. SPECIFIC GRANT INFORMATION subsection (e), shall be deleted and replaced with the following:

- 3. Except as modified by this AMENDMENT, the remaining terms and conditions of the AGREEMENT shall remain in full force and effect.




