SUPPLEMENTING FY25 BUDGET

WHEREAS, Section 129.06(2)(d), F.S., provides that receipts of a nature from a source not anticipated in the FY25 Budget, and received for a particular purpose may, by Resolution of the Board of County Commissioners of Pinellas County, be appropriated and expended for that purpose; and

WHEREAS, unanticipated revenues are to be received and these funds are to be appropriated and expended for the purpose for which received; and

WHEREAS, the Board of County Commissioners did, on October 27, 2024, advertise the date, time, place and purpose of the Public Hearing to amend the FY25 Budget pursuant to Section 129.06(2)(f), F.S., in the <u>TAMPA BAY TIMES</u>, a newspaper of general circulation in the County as provided herein.

WHEREAS, Section 129.06(2)(c), F.S., provides that appropriations from the reserve for future construction and improvements may be appropriated by resolution of the board for the purpose for which the reserve was made.

THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pinellas County, Florida, in a public meeting duly assembled this 17th day of December, 2024, that receipts from a source not anticipated and received for a particular purpose be appropriated and added to the Tourist Development Tax Fund, the TDT Debt Service Fund, and the total County budget for FY25 as follows:
