Climate Change Follow Up

Good Afternoon all! Over a year ago I spoke with you about the urgency of dealing with Climate Change: sea level rise, the need to invest in alternative energy sources, specifically Solar, and the need to write our Land Use Codes for the future. I am here today asking, "What, if anything, has been done to do so and save Pinellas County?"

You now have a study telling you how vulnerable are your facilities: buildings, roads, power facilities, transportation systems, and private businesses. You have much to do to make them safe and long term useable. Sea level rise is real and happening, now. You have three choices: adapt, armor, or abandon . Talk with Tarpon Springs officials. There are parts of Tarpon Springs in the next twenty-three years that will, probably, need to be abandon. It is a regional problem, but start with Pinellas County Cities and governmental units to coordinate a plan.

Are you willing to set a date (2035) by which time a percentage (50%) of Pinellas County facilities will be powered by solar? Five years ago, Tarpon Springs invested \$50,000 in a pilot Solar project. The 2018 budget has \$1, 257,000 more for solar over 5 years to power the RO Plant. It's cost effective, environmentally friendly, and the right thing to do. You should lead with them!

Have you reviewed your Land Use/Building Codes? You know there is land that should never be built on and land that **should never have been** built on. That is, if you care about saving Pinellas County.

Will Pinellas County have a 21 Century and Beyond People Mover System? It is 2018. Time is a waste-in'!

I'd think I deserve some feedback on these issues. Thank you for listening, but listening is not enough. You must act-now!

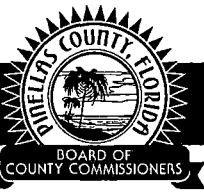

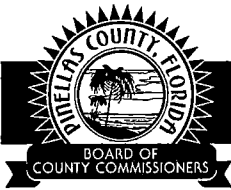

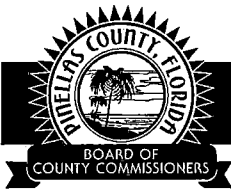
