This FIRST AMENDMENT entered into and effective this 1<sup>st</sup> day of October 2011 by and between the SOUTHWEST FLORIDA WATER MANAGEMENT DISTRICT, a public corporation of the State of Florida, whose address is 2379 Broad Street, Brooksville, Florida 34604-6899, hereinafter referred to as the "DISTRICT," and PINELLAS COUNTY, a political subdivision of the State of Florida, whose address is 315 Court Street, Clearwater, Florida 33756, hereinafter referred to as the "COUNTY."

WITNESSETH:

WHEREAS, the DISTRICT and the COUNTY entered into an Agreement effective June 30, 2010 (Original Agreement), for design, permitting and implementation of whole lake sediment removal in Lake Seminole, hereinafter referred to as the "PROJECT"; and

WHEREAS, the parties hereto wish to amend the Original Agreement to provide additional funding, due to higher than anticipated Consultant fees.

NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained herein, the parties hereby mutually agree to amend the Original Agreement, effective June 30, 2010, as follows:

1. Paragraph 3, Funding, is hereby amended to increase PROJECT funding \$435,424 by replacing the first two sentences in their entirety as follows:
  3. FUNDING. The parties anticipate that the total cost of the PROJECT will be Seventeen Million One Hundred Thirty-Five Thousand Four Hundred Twenty-Four Dollars (\$17,135,424). The DISTRICT agrees to fund PROJECT costs up to Eight Million Five Hundred Sixty-Seven Thousand Seven Hundred Twelve Dollars (\$8,567,712) and will have no obligation to pay any costs beyond this maximum amount.
2. Sub-Paragraph 3.7, is hereby amended to the extent that the DISTRICT and the COUNTY recognize that each of their Boards have approved \$567,712 (total \$1,135,424) for the PROJECT through Fiscal Year 2012.
3. The Exhibit "B" Project Funding is hereby replaced in its entirety with Exhibit "B" Project Funding (amended October 1, 2011) as follows.


