

FIRST AMENDMENT

This Amendment is made and entered into on the date last executed below ("Effective Date"), by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Insight Public Sector Inc., Chandler, AZ hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on September 19, 2023, referred to as Pinellas County Contract No. 23-0909-PB (hereinafter "Agreement"), pursuant to which the Contractor agreed to provide technology products and services for the County; and

WHEREAS, the Parties desire to amend the Agreement by mutual written agreement; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for an extension and an increase to the total contract expenditure, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

1. The term of the Agreement is hereby extended an additional twenty-four (24) months from April 30, 2026, to April 30, 2028, in conjunction with the cooperative procurement.
2. Section C ("Expenditures Cap") is revised to reflect an increase in the amount of \$4,500,000.00 to the current total not-to-exceed expenditure, for a revised total not-to-exceed expenditure of \$8,100,000.00.
3. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.

IN WITNESS WHEREOF the Parties herein have caused this First Amendment to be executed by their undersigned officials, who are duly authorized to bind the Parties to the Amendment.
